**NOTICE OF MAKING OF AN ORDER
HIGHWAYS ACT 1980
ESSEX COUNTY COUNCIL
PUBLIC PATH DIVERSION ORDER 2016
BRIDLEWAYS 90 & 112 GREAT WALTHAM IN THE CITY OF CHELMSFORD**

The above Order, made on 08 July 2016 under section 119 of the Highways Act 1980, will divert, as shown on the order map:

- i) a part length of Bridleway 112 commencing from a point at its junction with Bridleway 62 Great Waltham opposite the north western corner of the property known as Fitzjohns (CM3 1EJ), proceeding south across the tennis court and through the residential garden on the eastern side of the hedge boundary, exiting the garden curtilage to a point on the metalled access track outside the south western boundary corner of Fitzjohns (56752,21368), to an alternative route commencing from a point also at the junction of Bridleway 62 on the track between Fitzjohns and Fitzjohns Barn (56760,21379), proceeding in a southerly direction on the earth track then continuing on the metalled track south westerly to reach the aforementioned point outside the south western corner boundary of Fitzjohns.
- ii) a part length of Bridleway 90 commencing from its junction with Mashbury Road (56741,21319) on the northern side of the pond at Israel's Farm (CM3 1EH), proceeding southerly through the farm yard and outbuildings for a distance of approximately 143 metres to the farm track at the field edge, continuing easterly along the track to the hedge corner (56753,21304) on its southern side, to an alternative route commencing from a point connected with Mashbury Road opposite Israel's Bungalows (56755,213200), proceeding south at the field edge on the eastern side of the hedge adjacent to Murray Cottages, following the hedgerow westerly then southerly to reach the aforementioned point on the track at the hedge corner on its southern side.

A copy of the Order and the Order map have been placed and may be seen free of charge at Chelmsford City Council Offices, Civic Centre, Duke Street, Chelmsford CM1 1JE and at the Chelmsford Public Library, Market Road CM1 1QH during normal working hours. Copies are available on request from the Chelmsford Library at a charge.

Any representations about or objections to the order may be sent in writing to Andrew Ritchings, Definitive Map Service, Essex County Council, Seax House, 2nd Floor, Victoria Road South, Chelmsford CM1 1QH no later than 19 August 2016. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, Essex County Council may confirm the Order as an unopposed order. If the Order is sent to the Secretary of State for the Environment for confirmation any representations or objections which have not been withdrawn will be sent together with the Order. Any such representation or objections will be taken into account by the Council with the result that they may be made available to the public under the Local Government (Access to Information) Act 1985.
