

**The Essex County Council (Various Roads, Lawford)  
(Restricted Roads, 30mph and 40mph Speed Limit) Order 202\***

The Essex County Council in exercise of its powers under Section 84(1) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 1 to this Order.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This order shall come into operation on ..... and may be cited as The Essex County Council (Various Roads, Lawford) (Restricted Roads, 30mph and 40mph Speed Limit) Order 202\*
5. 'The Essex County Council (Tendring District) (Restricted Roads) (No.4) Order 2008' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Lawford.
6. 'The Essex County Council (Tendring District) (40mph Speed Limit) (No.2) Order 2010 is hereby revoked insofar as it relates to those lengths of road, in the Parish of Lawford.

### Schedule 1

30mph Speed Limit - Lengths of road at Lawford

<b>Bromley Road</b>	From its junction with A137 Wignall Street, south-eastwards for a distance of approximately 255 metres.
<b>Colchester Road</b>	From its junction with Station Road, southwards to its junction with New Road, a distance of approximately 1360 metres.
<b>Garden City</b>	For its entire length.
<b>B1352 Long Road/A137 Wignall Street</b>	From a point approximately 321 metres east of its junction with Colchester Road (the parish boundary), westwards to a point approximately 20 metres west of its junction with Dedham Road, a total distance of approximately 1721 metres.

### Schedule 2

40mph Speed Limit - Lengths of road at Lawford

<b>A137 Harwich Road (Wignall Street)</b>	From a point approximately 20 metres southwest of its junction with Dedham Road, south-westwards for a distance of approximately 650 metres.
