## The Essex County Council (Various Roads, Mistley) (Restricted Roads, 30mph and 40mph Speed Limit) Order 202*

The Essex Country Council in exercise of its powers under Section 84(1) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. No person shall cause or permit any vehicle to be driven at a speed exceeding 30 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 1 to this Order.
2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on those lengths of road, in the District of Tendring as specified in Schedule 2 to this Order.
3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
4. This order shall come into operation on $\qquad$ and may be cited as The Essex County Council (Various Roads, Mistley) (Restricted Roads, 30mph and 40mph Speed Limit) Order 202*.
5. 'The Essex County Council (Tendring District) (Restricted Roads) (No.4) Order 2008' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Mistley.
6. 'The Essex County Council (Tendring District) (40mph Speed Limit) (No. 2) Order 2010' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Mistley.
