5	<b>Public Questions</b> Two residents from Flag Hill, near Great Bentley, attended to raise concerns about safety and speed issues along the B1027. Both residents had attended their local parish councils, St Osyth and Great Bentley, and had their support in pursuing the issues. Officers advised they would review the road and also share the results with local parish councils so that local residents could feed into any actions as a result of the review. The issue would be brought back to the panel in the summer.

	<ul> <li>Advanced give way sign obscured by existing tree</li> <li>Road markings worn</li> <li>Poor conspicuity of Give Way sign</li> <li>Flag type direction signs missing</li> </ul>	
	Improve give way signage, increase conspicuity of Give Way Sign and relocate advanced give way sign) with yellow backing boards, re-apply junction markings, replace flag type direction signs, and vegetation removal. Consider advisory speed limit signs and bend ahead warning signing on the NB approach	
	Principle: A study of personal injury collisions at this location indicates a pattern of southbound road users from Wix Road turning right on to B1414 Harwich Road in to the path of oncoming vehicles.	
•	A133 Main Road jw B1029 Bromley Road; Intervention works: Proposal to carry out a feasibility study to change the traffic signals timings to allow separate northbound and southbound green phases.	
	Anecdotal evidence indicates this is a busy junction, particularly during peak times, so road users gap acceptance may be reduced.	
	Principle: A study of personal injury collisions at this location indicates a pattern of northbound road users turning right across the path of southbound road users at the signalised junction. None of the collisions involved road users disobeying a red signal on the junction. An additional collision in September 2019 of similar nature has been recorded.	
•	A133 Clacton Road approx. 1.5km south east of Elmstead	
	<ul> <li>Market</li> <li>Intervention works: It was noted during the site visit:</li> <li>Wide single carriageway with centre hatching.</li> <li>Double bend with first southbound radius greater than would be considered for provision of chevron signs.</li> <li>Existing verge markers in poor condition.</li> </ul>	
	Upgrade existing bend warning signs with yellow backing boards. Consider additional advisory speed limit plate, vegetation clearance, verge marker posts. It may be appropriate to carry out the proposals during, or as part of, the programmed resurfacing works to minimise disruption.	
	Principle: A study of personal injury collisions at this location indicates a pattern of loss of control collisions on a wet/damp carriageway surface. Two collisions were travelling north west to south east, two collisions were travelling south east to north west. However, one of the south east to north west collisions was due to an oncoming vehicle crossing in to opposing lane.
