

The Essex County Council (Fairmead Road, Waltham Abbey) (Prohibition of Motor Vehicles) Order 2013

The Essex County Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) and 3(2) and Part IV to Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III to Schedule 9 to the Act, hereby makes the following Order:-

1. In this Order
"motor vehicle" has the same meaning as in Section 136 of the Act.
2. Save as provided in Article 3 of this Order, no person shall cause any motor vehicle to proceed in Fairmead Road, Waltham Abbey in the District of Epping Forest, from a point approximately 50 metres south of its junction with Cross Roads for its entire remaining length (hereinafter referred to as the 'said length of road').
3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing any motor vehicle to proceed in the said length of road if the vehicle:-
 - (a) is being used for fire and rescue, police or ambulance purposes;
 - (b) is being used in connection with any of the following operations, namely:-
 - (i) the maintenance, improvement or reconstruction of those lengths of road;
 - (ii) the laying, erection, alteration or repair in or on land adjacent to the said length of road, of any sewer, or any main, pipe or apparatus for the supply of water, gas or electricity, or any telegraphic line; or
 - (iii) is being used for agricultural or forestry purposes;
 - (d) is being used in the service of or contracted to a local authority or water authority in pursuance of statutory powers or duties.
 - (e) in any case where the person in control of the vehicle is required by law to stop, or is obliged to do so to avoid an accident, or is prevented from proceeding by circumstances beyond his/her control.
4. The Council are satisfied that for avoiding danger to persons or other traffic using the road to which the order relates or any other road, and for preventing the likelihood of any such danger arising, it is requisite that Section 3(1) of the 1984 Act should not apply in relation to this Order.
5. 'The Epping Forest District (Fairmead Road, Loughton) (Prohibition of Driving) Order 1977' is hereby revoked.



6. This Order shall come into operation on 6 September 2013 and may be cited as The Essex County Council (Fairmead Road, High Beach) (Prohibition of Motor Vehicles) Order 2013.
