## The Essex County Council (Colchester City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places)(Civil Enforcement Area) (Amendment No.67) Order 202\*

**Notice is hereby given that** further to a notice on the 02 January 2025, the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended). Amendments have been made to the timings of the restrictions, and to measurements on Mill Road.
