The Essex County Council (hereinafter referred to as "The Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53, Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1. To revoke: No Waiting Thursday 6am - 6pm Restriction on the following lengths of road,

Road Name	Description
Stoneham Street, Coggeshall	EAST SIDE: From a point approximately 20 metres South of its junction with Robinsbridge Road, South for approximately 94 metres

2. To revoke: 'No Waiting at Any Time' Restriction on the following lengths of road,

Road Name	Description
Stoneham Street, Coggeshall	EAST SIDE: From a point approximately 19 metres North-West from Stoneham Street Access Road (otherwise known as Crouch End) South, for approximately 4.5 metres

3. To implement: 'No Waiting at Any Time' Restriction on the following lengths of road,

Road Name	Description
Stoneham Street, Coggeshall	i. EAST SIDE: From a point approximately 20 metres South of its junction with Robinsbridge Road, South for approximately 38 metres. ii. WEST SIDE: From a point approximately 19 metres North-West from Stoneham Street Access Road (otherwise known as Crouch End) North, for approximately 64 metres

4. To implement: 'No Waiting Mon-Sat 8am-6pm' Restriction on the following lengths of road

Road	Description
East Street, Coggeshall	NORTH SIDE: From a point in line with the western boundary of property number 62 East Street, East for a distance of approximately 30 metres.
