

**The Essex County Council (Epping Forest District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.52) Order 202\***

The Essex County Council (hereinafter referred to as “The Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1),45, 46, 49, 53, and Parts IV and III of Schedule 9 of the Road Regulation Act 1984 (as amended), (hereinafter referred to as “the Act”), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

- 1. To Introduce:** 'a 24 hour Clearway (No Stopping at Any Time on main carriageway) **includes** Campions, Western and Eastern Dumbbell Roundabouts (Sheering and Matching Parish)

A1025 Gilden Way, <b><u>Epping Forest</u></b>	<b>Both Sides:</b> From the eastern kerb line of Marsh Lane (the boundary of Harlow District and Epping Forest) north and east, for approximately 1500 metres (to include the circulatory of all three roundabouts and the connecting roads.)
Sheering Road, <b><u>Epping Forest</u></b>	<b>Both Sides:</b> From its junction with A1025 Gilden Way west for approximately 23 metres.
B183 Sheering Road, <b><u>Epping Forest</u></b>	<b>Both Sides:</b> From its junction with A1025 Gilden Way north for approximately 35 metres.

- 2. To Introduce:** 'a 24 hour Clearway (No Stopping at Any Time on footway and verge) **includes** Campions, Western and Eastern Dumbbell Roundabouts (Sheering and Matching Parish)

<b>Road</b>	<b>Description</b>
A1025 Gilden Way, <b><u>Epping Forest</u></b>	<b>North Side:</b> From the eastern kerb line of Marsh Lane (the boundary of Harlow District and Epping Forest) east and north, for approximately 500 metres <b>Both Sides:</b> From The Campions Roundabout south and east to the Eastern Dumbbell Roundabout approximately 1000 metres (to include the circulatory of all three roundabouts and the connecting roads.)
Sheering Road, <b><u>Epping Forest</u></b>	<b>Both Sides:</b> From its junction with A1025 Gilden Way west for approximately 23 metres.
B183 Sheering Road, <b><u>Epping Forest</u></b>	<b>Both Sides:</b> From its junction with A1025 Gilden Way north for approximately 35 metres.
