

The Essex County Council (Various Roads, North Weald Bassett, Epping Forest and Harlow) (Combined Speed Limit) Order 202*

The Essex County Council ("the Council") in exercise of its powers under Sections 81, S82(1) & (2)(a), 83(2), 84(1) (a) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1. No person shall cause any motor vehicle to proceed at a speed exceeding 30 miles per hour in the lengths of road, in the Parish of North Weald Basset, in the District of Epping Forest as specified in Schedule 1 to this order.
2. No person shall cause any motor vehicle to proceed at a speed exceeding 40 miles per hour in the lengths of road, in the Parish of North Weald Basset, in the District of Epping Forest as specified in Schedule 2 to this order.
3. The Length of Road specified in Schedule 3 to this order shall cease to be a restricted road for the purposes of section 81 of the Act.
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3 (5) of those regulations.
5. 'Epping Forest District (B181 Epping Road, North Weald) (60 Miles Per Hour Speed Limit) Order 1992' is hereby revoked in its entirety however, all restrictions shall continue in force by virtue of this new Order
6. 'Epping Forest District (Coopersale Common) (30 Miles Per Hour Speed Limit) Order 1997' is hereby revoked in its entirety however, all restrictions shall continue in force by virtue of this new Order.
7. 'The Essex County Council (Various Roads, North Weald Bassett) 40MPH Speed Limit) Order 2010' is hereby revoked in its entirety however, all restrictions shall continue in force by virtue of this new Order.
8. 'The Essex County Council (Woodside, North Weald Bassett) (Restricted Road) Order 2013' is hereby revoked in its entirety however, all restrictions shall continue in force by virtue of this new Order.
9. 'The Essex County Council (A414 London Road & London Road. District of Epping Forest & Harlow) (40MPH and 50MPH Speed Limit) Order 2017 'is hereby revoked insofar as it relates to schedule 1 of that order, all restrictions not mentioned shall continue in force by virtue of the existing Order.

Schedule 1 - 30mph

Road	Description
Woodside, North Weald Bassett	From Its junction with B1393 High Road in a generally south easterly direction, for approximately 1100 meters

Schedule 2 - 40mph

Road	Description
B181 Epping Road, North Weald Bassett	From a point approximately 7 metres from the extended eastern kerb line of The Plain to a point approximately 64 metres north west of the north eastern extended kerb line of Coopersale Common. For a total length of approximately 597 metres
Coopersale Common, North Weald Bassett	From the junction of B181 Epping Road Southeast for approximately 218 metres
A414 London Road, North Weald Bassett and Harlow District	Both Carriageways: From the junction with the circulatory carriageway of Hastingwood Roundabout at the northbound exit and southbound entry, northwards to a point approximately 120 metres north of the roundabout at its junction with Church Langley Way
London Road, North Weald Bassett	From its junction with the A414 London Road east and then north for a distance of approximately 89 metres
Foster Street, North Weald Bassett	From its junction with Harlow Common/ Mill Street, northeast of the common boundary of No 1 and 2 Foster Street /cottages, a distance of approximately 829 metres
Harlow Common, North Weald Bassett	From its junction with London Road, northeast, to its junction with Foster Street/ Mill Street, a distance of Approximately 1095 metres
Hastingwood Road, North Weald Bassett	From its junction with A414, northeast, to a point approximately 15 metres northeast of the north-eastern flank wall of the Hannah House, a distance of approximately 1597 metres.
Mill Street, North Weald Bassett	From its junction with Harlow Common/ Foster Street, southeast, to its junction with Hastingwood Road, a distance of approximately 1077 metres.

Schedule 3 - Derestricted Road

Road	Description
B181 Epping Road, North Weald Bassett	At its junction with Roughtallys and a point approximately 80 metres south-west of its junction of the B181 Epping Road with Woodside, Thornwood, a distance of approximately 775 metres
