

## **The Essex County Council (Various Roads, Old Harlow) (7.5 tonne Environmental Weight Restriction) Order 202\***

The Essex County Council (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (4), 3(2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

1. In this Order:-

“goods vehicle” means a motor vehicle or trailer constructed or adapted for use for the carriage or haulage of goods or burden of any description

2. Save as provided in Article 3 of this Order no person shall cause any goods vehicle having a maximum permissible gross weight exceeding 7.5 tonnes to proceed in the said lengths of roads in the District of Harlow as specified in the Schedule to this Order [hereinafter referred to as the said length of road].

3. Nothing in Article 2 of this Order shall apply so as to prevent any goods vehicle having a maximum permissible gross weight exceeding 7.5 tonnes to proceed in the length of roads if the vehicle is being used

(a) for the conveyance of goods or merchandise to or from any premises situated on or adjacent to the length of roads.

(b) except upon the direction or with the permission of a police constable in uniform.

(c) for the purpose of agriculture in connection with land in or adjacent to the length of roads; including the delivery and transportation of goods and services to and from these agricultural premises.

(d) for fire and rescue, police or ambulance purposes, in the exercise of their duties.

(e) is being used in connection with any of the following operations, namely;

(i) in connection with any building or demolition operations in or adjacent to the length of roads.

(ii) for the removal of any obstruction to traffic in or adjacent to the length of roads.

(iii) for the maintenance, improvement or reconstruction in or adjacent to the length of roads.

(iv) for the laying, erection, alteration or repair in or on land adjacent to the length of roads, of any sewer, or any main, pipe or apparatus for the supply of water, gas or electricity, or any telegraphic line.

- (v) in the service of a local authority or water authority in connection with work being carried out in or on land adjacent to the length of roads, in pursuance of statutory powers or duties.
- 4. The Council is satisfied that for preserving or improving the amenities of an area by prohibiting or restricting the use on a road or roads in that area of heavy commercial vehicles it is requisite that Section 3(1) of the 1984 Act (as amended) should not apply in relation to this Order.

## Schedule

### Effect of the order:

1. **To Introduce** a '7.5 tonne Environmental Weight Limit' on the following roads (starting points) in Old Harlow, in the District of Harlow

Road	Description
Mulberry Green (Marked 40 on plan)	From its junction with Gilden Way (A1025) west for its entire length approximately 384 metres.
London Road (Marked 21 on plan)	From its junction with First Avenue/Mandela Avenue/Gilden Way (A1025) north to for its entire length approximately 384 metres.
Station Road (Marked 46 on plan)	From its junction with the Harlow Mill Roundabout east and then north and south for its entire length for approximately 742 metres.
Old Road (Marked 41 on plan)	from its junction with Wheatfield, south for its entire length to its junction with Mulberry Green.

2. **To Introduce:** a '7.5 tonne Environmental Weight Limit' on the following roads for their entire lengths, in Old Harlow, in the District of Harlow
