As part of the Essex County Council 2017/18 budget the 2017/18 Capital Budget for the Castle Point Local Highways Panel (LHP) will remain the same as that for 2016/17, namely £228,675.

CASTLE POINT BOROUGH COUNCIL WITH ESSEX COUNTY COUNCIL LOCAL HIGHWAY PANEL – 27TH JUNE 2017 REPORT 3 – POTENTIAL CAPITAL SCHEMES

As the capital budget for the Castle Point Highways Panel has been fully committed the potential schemes list represents all of the schemes for which future consideration can be given.

It is recommended that Parishes or Councillors who wish to submit scheme requests for 2018-19 submit them as soon as possible so that all of the necessary surveys and assessments can be undertaken in the coming months.

A comprehensive list of schemes will then be available in time for Members to consider for funding at the January Panel.

The value of the schemes currently on the potential list stands at \pounds 168,000 of which \pounds 153,000 is internally generated, with further value set to be added throughout the year once feasibility studies and recent validations have been returned.

Members are reminded that the costs supplied are estimates only and there is the possibility that a final scheme cost can change significantly dependent on issues which may arise during detailed design and construction.

The following list identifies all of the scheme requests which have fed into the Castle Point LHP. The RAG column acknowledges what the status of the scheme request is as below:

CASTLE POINT BOROUGH COUNCIL WITH ESSEX COUNTY COUNCIL LOCAL HIGHWAY PANEL – 27th JUNE 2017 REPORT 4: HIGHWAYS RANGERS

The process surrounding making requests for works by the Castle Point Rangers has recently changed.

In line with a uniformed process across all twelve District / Borough and City Councils in Essex all Parishes and Councillors in Essex were emailed in April 2017 outlining the new way of working.

The main amendment being that requests are to be completed on the Rangers Request form supplied in the email and returned to the dedicated LHP Rangers email address instead of submitting the request using the online portal. Requests can still be submitted directly to the Castle Point Borough Rangers team.

Requests will then be collated and submitted to the Rangers team on a monthly basis.

We will be unable to provide timescales for when specific requests will be attended to as the nature of the request and the time of year will dictate the priorities which will be assigned by the Rangers team.

The lists of requests and completion dates where appropriate will be reported back to the Panel at the quarterly LHP meetings along with all the work generated through Castle Point Borough Council.
