Members were reminded that the capital budget for Braintree Local Highways Panel for 2017/18 was £407,789. From this sum, £28,000 had been allocated to safer roads schemes and, in total, schemes to the value of £315,500 were programmed to be delivered in 2017/18. The total value of schemes in the rolling programme for 2018/19 was £210,500.

#### RANGERS WORKS

The process surrounding making requests for works by the Braintree Rangers has recently changed.
