1.	Welcome and Introductions:	
	Councillor Mrs J Beavis, Chairman of the Local Highways Panel, welcomed everyone to the meeting and she invited those present to introduce themselves.	
	In particular, the Chairman welcomed Members of Braintree District Council's Overview and Scrutiny Committee which was currently conducting a Scrutiny Review into the role of the Highway Authority in the Braintree District. Members of the Committee had been invited to observe this meeting of the Panel.	



# Local Highways Panel - Changes and Revised Terms of Reference:

Councillor Mrs Beavis reported that a meeting of County-wide Local Highways Panel representatives had been held at Country Hall. Chelmsford on 3rd April 2018 to discuss how the Panels were operating and if any changes should be made. A further meeting had taken place in September 2018 at which Councillor Bentley, Essex County Council's Cabinet Member for Infrastructure had indicated that he proposed to introduce changes to the way in which the Panels operated. One of these changes would enable all County Councillors in an area to attend meetings of their Local Highways Panel and to have voting rights. All County Councillors would receive training on highway matters. In addition, at least one Member of each Panel would be appointed to represent Parish Councils in the area. Councillor Mrs Beavis was pleased to report that some of the changes already applied to the Braintree Highways Panel and that they would not be a detriment to the way in which the Panel operated. New Terms of Reference would follow.

As part of the Cabinet Member's improvements, a Highways Highlights Bulletin which contained information about highway matters was being published on a regular basis.

#### **Cycling Officer's Report:**

Councillor Mrs Beavis was pleased to welcome Mr Kris Radley, Essex County Council's Cycling Officer to the meeting and she invited Mr Radley to give a presentation to Members of the Panel on the County Council's Cycling Strategy.

Mr Radley stated that the aim of the Strategy, which had been adopted in 2016, was to enable people to cycle safely and more often and to double the number of people cycling by 2025 in line with the Department of Transport's target. People would be encouraged to treat cycling as an everyday activity, which would help to reduce congestion, improve air quality and enhance the health and well-being of local people. The key themes of the Strategy were cycle path design best practice; to promote behavioural change regarding modes of travel; to encourage high profile cycling events to take place in Essex; and to provide a coherent cross-County cycle network.

Cycling Action Plans for a cycle network had been prepared for each District/Borough in the County. These were available to view on Essex County Council's website. The Cycling Action Plans would assist in seeking funding from the Department of Transport via the Local Cycling and Walking Infrastructure Plan process (LCWIP). In particular, it was proposed that key cycling corridors should be



	established in the County. Braintree, Chelmsford and Colchester were key target towns and it was proposed that they should link to a strategic network. It was hoped that funding for this network would be obtained from the Department of Transport in the 2019/20 financial year.  Following his presentation, Mr Radley answered questions raised by Members of the Panel.

	The Minutes of the meeting of Braintree Local Highways Panel held on 29th March 2018 were approved as a correct record and signed by the Chairman, subject to Minute 11 (Date of Next Meeting) being amended to indicate that the next meeting of the Panel would take place on 11th October 2018 (the meetings scheduled for 21st June 2018 and 20th September 2018 had been cancelled).	
5.	Matters Arising from Minutes of the Previous Meeting:	
	It was reported that all action points which had been recorded at the meeting of Braintree Local Highways Panel held on 29th March 2018 had been dealt with and updates were provided.	
	The following matters were raised:-	
	Minute 3 – Public Questions (Scheme LBRA142006 - Carriageway widening, installation of footpath and new kerbing at the B1018 Braintree Road, Cressing)	
	Members of the Panel expressed their appreciation for the maintenance work which had been carried out at this location. However, it was acknowledged that this was a temporary measure and that a permanent solution was required. It was queried whether	



such work could be carried out as part of Highways England's proposed construction of 'on' and 'off' slip roads at Millennium Way, Braintree, but Members were advised that the slip roads project would not include improvements to the B1018. A more permanent scheme was proposed which was dependent on a local land owner making land available and planning permission being granted for a development proposal. It had also been suggested that the scheme could be funded from the 'New Homes Bonus'.

Members were aware that although this scheme had been discussed for many years, it remained a priority as the site was very dangerous. It was reported that if the value of the work exceeded £250,000, it would be categorised as a capital scheme and it would not be funded from the Local Highways Panel's budget.

#### Minute 6 - Finance Update

A financial update relating to schemes implemented in the 2017/18 financial year was circulated at the meeting. This showed budget allocation and predicted expenditure for each scheme and it indicated a number of variances.

Further financial information was provided during the consideration of Item 6 - Approved Works Programme. The discussion relating to this information is recorded in Minute 6 of this meeting.

#### Minute 7 – Approved Works Programme

Reference was made to an on-going flooding issue at Mill Lane/Guithavon Valley, Witham, which related to the inadequacy of existing drains and insufficient drainage. In an update, it was reported that design work would be undertaken during the 2018/19 financial year. As the work had been categorised as a capital, surface water alleviation scheme, it would not be funded from the Local Highways Panel's budget. It was anticipated that the scheme could be implemented in early 2019.



#### 6. Approved Works Programme:

Consideration was given to a report setting out a programme of schemes which the Panel had recommended for approval. The report provided an update on the current position of all schemes which had been recommended for inclusion in the 2017/18 and 2018/19 programmes of work. The schemes denoted in 'green' had been completed; those denoted in 'grey' had been cancelled and could be removed from the schedule; and those denoted in 'yellow' were to provide an update to the Local Highways Panel. The report also included schemes which had been prioritised for implementation in 2019/20 as part of a rolling programme.

In an update to the budget position, it was reported that some high value schemes had been cancelled and that a number of small scale schemes which had been carried out by the 'Direct Delivery Team' had been implemented at a reduced cost. In the circumstances, funding was available to implement up to 13 'Direct Delivery Team' schemes plus £100,000 for other schemes contained within the rolling programme and on the list of potential schemes during the 2018/19 financial year.

In discussing this Item, it was reported that top-up funding was required for schemes LBRA155005, LBRA181004 and LBRA175001. Members of the Panel agreed that top-up funding should be provided as detailed in paragraph (4) below.

#### 9. Any Other Business:

#### **Potential Schemes Comparison:**

Councillor D Smith referred to an E-Mail which he had circulated to Members of the Panel on 10th October 2018 setting out the results of his analysis of the Potential Schemes List. Councillor Smith explained that the analysis related to the lists prepared for the Panel's meeting scheduled for 21st June 2018, which had subsequently been cancelled, and for the meeting of 11th October 2018.

Councillor Smith stated that between June and October 2018 there had been a small increase in the number of schemes on the List from 74 to 85, but that the total value of the schemes had increased from £419,500 to £763,750.

In order to manage the Potential Schemes List in a better way, Councillor Smith suggested that Ringway Jacobs/Essex County Council should provide estimated costs when validating new schemes.

# **Braintree Local Highways Panel - Appointments With Jasmine Wiles, Assistant Highways Liaison Officer:**

The Chairman reported that Jasmine Wiles, Essex Highways Assistant Highways Liaison Officer had arranged to work from Causeway House, Braintree on the last Thursday of every month to enable Councillors to meet with her to discuss highway related issues. This new arrangement had commenced in July 2018 and it was working well. It was suggested that details of this facility should be forwarded to the Parish and Town Councils in the District. Members of the Panel commended this new initiative and other recent changes which had improved the way in which the Panel operated.

It is envisaged that the 2019/20 Capital budget for the Braintree LHP will be the same as that in 2018/19 (£407,789), though this will be finalised by ECC at their full Council meeting in February 2019.

There are five Casualty Reduction schemes in Braintree which will need to be funded from this pot so this figure is subject to change once the costs have been confirmed.

Members are therefore invited to commence prioritising schemes which will then be finalised at the final meeting of the year. As with previous years a mix of feasibility studies and physical works are recommended to help form a deliverable programme.

Costs supplied are estimates only and there is the possibility that a final scheme cost can change significantly dependant on issues which may arise during detailed design and construction.
