1.	Welcome and Introductions:	
	Councillor Mrs J Beavis, Chairman of the Local Highways Panel, welcomed everyone to the meeting and she invited those present to introduce themselves.	
	Councillor Mrs Beavis reported that she had continued her tour of	



the District and she drew attention to photographs circulated at the meeting showing recently completed schemes. Councillor Mrs Beavis would be continuing with further visits.

Councillor Mrs Beavis commended Members of the Panel for their continued interest and work in between meetings and she wished to record her thanks to Jasmine Wiles for responding promptly to queries raised by Members via E-Mail.

Councillor Mrs Beavis informed Members of the Panel that a meeting of County-wide Local Highways Panel representatives would be held at Country Hall, Chelmsford on 3rd April 2018 to discuss how the Panels were operating and if any changes should be made. The outcome of the meeting would be reported to the Panel.

2. Apologies for Absence and Declarations of Interest:

Apologies for Absence

Apologies for absence were received from Councillor J Bendall (BALC), Councillor G Butland (BDC) and Councillor S Canning (ECC).

There were no interests declared.

3. Public Questions:

There following statements were made:-

A statement was made by Councillor B Rose, BDC Councillor for Witham West Ward and Witham Town Councillor of 110 Humber Road, Witham regarding Scheme LBRA162004 - Chipping Hill Bridge, Chipping Hill j/w Powers Hall End, Witham This matter was discussed under Agenda Item 7 - Approved Works Programme (Minute 7 refers).

A statement was made by Mr J Konig of Bridport Way, Braintree regarding Scheme LBRA142006 - Carriageway widening, installation of footpath and new kerbing at the B1018 Braintree Road. Cressing.

Members of the Panel reiterated their concern about the current state of this stretch of road and that urgent maintenance work was a major priority.

Councillor R Mitchell, Essex County Council, Deputy Cabinet Member for Highways reported that emergency repairs were being carried out. It was reported that, as Essex Highways did not own the land either side of the road, discussions would take place with



	the relevant land owners regarding the proposed maintenance work. Councillor Mitchell agreed to keep Members of the Panel updated with progress on this matter.

Councillor Abbott queried if the work had been completed, whether the crossing point had been delivered	
	and whether the right of way priorities at the junction were as originally proposed. Action By: Jasmine Wiles, Essex Highways. 6. Finance Update:

It was reported that financial information relating to Braintree Local Highways Panel would be discussed at a meeting of County-wide Local Highways Panel representatives which would be held at Country Hall, Chelmsford on 3rd April 2018. In the circumstances, it was agreed that the consideration of this Item should be deferred to the next meeting of the Panel.

7. Approved Works Programme:

Consideration was given to a report setting out a programme of schemes which the Panel had recommended for approval. The report provided an update on the current position of all schemes which had been recommended for inclusion in the 2017/18 programme of work. The schemes denoted in 'green' had been completed; those denoted in 'grey' had been cancelled and could be removed from the schedule; and those denoted in 'yellow' were to provide an update to the Local Highways Panel.

The report also included schemes which had been prioritised at the Panel's meeting in January 2018 for implementation in 2018/19. These schemes were subject to formal approval by Essex County Council's Cabinet Member for Highways.

It was reported that the capital budget for Braintree Local Highways Panel for 2018/19 would be £407,789. It was proposed that £288,500 of this sum should be allocated to schemes which had been prioritised for implementation in 2018/19; £8,500 to schemes re-profiled from 2017/18 to 2018/19; and £126,500 to safer roads schemes. In total this amounted to an overspend of £15,711. However, Members of the Panel were advised that final scheme costs could change. Members of the Panel were also advised that Essex Highways had assigned a 'Direct Delivery Team' for all 12 Local Highways Panels. The Team would comprise three members of staff who would carry out small scale schemes such as signing; lining; and kerbing specifically for the Panels. It was anticipated that this new service would improve effectiveness and efficiency and reduce costs. It was suggested that the role of the Direct Delivery Team should be discussed at the next meeting for the Panel.

Reference was made to the significant proportion of the Panel's budget (£126,500), which had been earmarked by Essex County Council's Cabinet Member for Highways for safer roads schemes. However, it was reported that a decision had not yet been made as to exactly how these schemes should be funded. It was suggested



that this matter should be raised at the meeting of County-wide Local Highways Panel representatives which would be held at Country Hall, Chelmsford on 3rd April 2018.

Members of the Panel drew attention to a flooding issue at Mill Lane/Guithavon Valley, Witham, which was causing problems in a well-used area serving a care home, schools and commuters. The relevant Authorities were aware of the problem, which related to the inadequacy of existing drains and blocking by leaves, and insufficient drainage. It was mentioned that a feasibility study had been carried out, but potential funding had had to be allocated to other schemes. It was hoped that the work could be funded from other sources.

Councillor D Smith stated that there was a discrepancy between the version of the Approved Works Programme included within the Panel's Agenda and the Programme which was available to view on Braintree District Council's website. It was agreed that this issue should be investigated.
