5. Update –

*Overview of Map Essex and Panel Future (Including LHP scheme proposal form)

Jon addressed the Panel with regards to an overview of Map Essex and explained how they can access and view highway issues on the map. He informed the Panel that this was purely for information and they were looking at placing Local Highway Panel works on to the maps, so the Panel would be able to see what was actively happening and where should they have any resident queries.

* Direct Delivery 18/19 Success

Jon gave a presentation to the Panel with an update on the Direct Delivery service.

He explained to the panel that since delivering in-house it has become more efficient in getting work done and cost effective too. The type of work included with in the Direct Delivery team are signing, lining and tactile paving.

Jon informed the Panel that since starting, because of the Direct Delivery gangs, their jobs that would normally take 12 weeks to implement can now only take 4-6 weeks and this has helped build up a substantial saving. By using the Direct Delivery gangs across the County scheme costs had been reduced from around £1.15 million down to £437,000.

In response to questions from the Panel Jon explained that all scheme requests should be applied for in the usual way and at the moment it was still just the smaller jobs that the Delivery Team can action. He explained that they do not have access to diggers or larger machinery.

6. Report on Funded Schemes 2019/20

Jon introduced the report and firstly explained to the Panel how they have renamed the reports as Funded Schemes (previously the Approved Works Programme) and Schemes Awaiting Funding (previously the Potential Schemes List) and they will be reported back to Committee every quarter. Jon informed the Panel of a slight change to the figures since March 2019. The total amount needed for schemes to be funded is now £301,300 instead of £160,500. He also told the Panel that due to a change in bus stop procurement, Bus Stops were currently on hold.

Jon informed the panel that the following Funded Schemes had not progressed in the financial year, so the money had been put back in to the Local Highways Panel budget for 2019/20. These were;

Sonia updated the panel on the desire to lay an anti-skid surfacing however due to the existing surface quality this would not be possible. A full surface would need to be laid. The lining also requires replacement. The surfacing is not programmed to be completed within the next two of years.

In response to questions from the Panel Sonia informed them that the street lighting was being investigated and was currently being discussed by designers for both the crossing and the approaching road.



The Panel asked for this scheme to be sent back to maintenance and comeback at a later date with the framework.

The Panel also requested that a list of the Bus Stops waiting on the scheme list come back to the next meeting, so they can be agreed in advance of the April 2020 meeting.

Cllr Lissimore asked why scheme No. 15 Shrub End Road, Colchester - Pedestrian crossing LCOL153006, was declared a green scheme when nothing had been done since her request. Sonia informed Cllr Lissimore due to the location of the crossing and safety assessment it was at a very tricky location with regards to the shops and Texaco Petrol station. Sonia did advise if necessary they could arrange for a design to be made to get an idea of what could been done and costings. Sonia informed the Panel that to put a zebra crossing in would cost around £65,000 and a design would cost around £5000.

A vote was taken by the Panel and a majority agreed to leave the scheme in and for Sonia to go back to Cllr Lissimore when a design has been completed and assessed.
