Traffic Management

HLO informed speed surveys are now underway, however there are a lot from across all the districts so will take some time to complete.

There is £55K of funding that needs to be allocated to schemes as soon as possible. SA & BE have discussed the schemes awaiting funding, and which of the ones marked as Green are deliverable this late in the year and made recommendations, there are 2 quarters left. Sites discussed were:

Ref 1: LCAS192024 – A13 jw Rushbottom Lane & Church Road, Thundersley – Traffic Management Improvements

Cllr Egan suggested this feasibility project as a possibility to be included in the £55k that needs to be spent. There are issues with the traffic congestion and would tie in with the Tarpots scheme.

Ref 2: LCAS192025 - Daws Heath Road – Speeding

Ref 3: LCAS192026 – Falbro Crescent -20mph and signing

HLO to arrange meeting to discuss the 2 projects above with Cabinet Member Cllr Maclean and Ian Butt, as Cllr Hart raised that they are identified in the Local Plan.

Ref 9: LCAS192023 – Tarpots, London Road, Benfleet – Traffic Management

Cllr Skipp raised this as a priority due to another accident occurring recently and there has been a long wait for this scheme. Cllrs Egan, Hart, Reeves and Chair reiterated the point and ongoing problems caused at this junction.

BE informed that the right turn needs to be addressed, the island extended and look to have more signage.

Ref 10: LCAS192027 – Third Avenue, Northwick Park School – Traffic Management Improvements

This is a project for next year as it requires a TRO.

Ref 11: LCAS202001 – Watlington Road jw Loten Road, Benfleet - Kerbing

Due to drainage issues it is not possible to carry this out this year.

Ref 12: New Road jw Long Road, Canvey Island – Signage

Cllr May raised concern as vehicles are entering in the wrong direction, it is dangerous, there needs to be more signage.

Cllr Acott highlighted that the Off Licence could be where the main issue is, as their delivery lorries enter the wrong way and pull up outside the store causing a hazard.

Chair asked TB if it would be appropriate for someone to speak with the Shopkeeper. TB informed that SJ could speak to the Shopkeeper and liaise with Cllrs Acott/May, it may not solve the issue completely but may ease the problem.

Ref 16: Seaview Road and Eastern Esplanade, Canvey Island – Traffic Calming

Cllr May informed this project links to the Regeneration Team.

Walking

Ref 6: LCAS203001 Thorney Bay Road (Sandy Bay), Canvey Island – Footway

A discussion was had surrounding this project. Cllr May highlighted the need for a footway is urgent, a temporary gravel surface until such a time the project can be completed fully is needed due to concerns that this area has a busy footfall with school children and elderly residents with mobility issues. HLO advised it may be helpful to approach Sandy Bay to see if they can help. BE advised against using gravel as a temporary surface, Cllr May requested that this still be considered if there were any further savings identified.

Ref 7: LCAS203002 – Leigh Beck Lane, Canvey Island – School KEEP CLEAR

Cllr Acott raised on behalf of Cllr Blackwell. This scheme may be more of a priority due to the School now using the back entrance more frequently. HLO will contact the Head Teacher of the School and liaise with Cllr Blackwell.

Ref 9: LCAS203004 – Thorney Bay Road jw Long Road, Canvey Island – Dropped Crossing

Project discussed as a possibility to include in the projects to be completed as part of the £55K funding to be spent. No other comments raised.
