4.	Matters Arising from Minutes of the previous meeting:	
	High Road, Canvey Island Councillor Acott stated that he had received the report regarding the accident in which a vehicle had gone the wrong way along the one way system. The report had stated that there was no issue with the crossing at this location but Councillor Acott stated that the accident was nothing to do with the crossing, he believed it was due to the signage in the vicinity. Sarah Alcock to speak to Councillor Acott outside of the meeting to establish the issue.	SA
	Benfleet Station Feasibility Study Members had been asked by email on 11 th August to agree an increase of £20,000 to complete the data collection and modelling required to fully investigate the impact of implementing a one-way system around Benfleet Station. All Panel Members had agreed and the scheme was now awaiting sign off by the Cabinet Member for Highways. The Chairman stated that as part of the study he had requested that a one-way system be looked at in both directions in the roads around the car park.	
5.	Approved Works Programme Update 2017/18:	
	The Panel considered a report on all schemes which had been recommended at previous meetings and noted the budget summary for 2017/18. The following comments were made:	
	LCAS161006 – High Road Benfleet – SA explained that once the last beacon had been connected then the old columns would be removed.	
	LCAS162053 – St Michael's Road, Hadleigh – An additional chevron had been recommended by the Road Safety Audit Team. The updated design document would be shared with the County Member.	
	LCAS162055 – Kents Hill Road North junction with A13 - SA reported that the change to the stop line would now necessitate some works/changes to signals at the location. It was estimated that the additional cost would be £5,000. The Panel Members agreed to the additional cost.	
	LCAS171001 – Link Road j/w Third Avenue, Canvey Island - Panel Members queried the need for a new zebra crossing at the site as it had been suggested to move the zebra crossing at the junction with Dinant Avenue. SC explained that this was a Casualty Reduction Scheme which would be designed this financial year and brought back for consideration next year.

	Councillor Mrs Egan reported that many compliments had been received from residents regarding the newly installed shelter at Raymond's Drive, Thundersley.	
	Councillor May raised concern that local businesses had offered to install a new bus shelter in Long Road, Canvey Island providing they could advertise in it and had been told they would be made responsible for the bus shelter. SA to liaise with passenger Transport and find out if this is possible.	SA

	Section 106 Schemes SA reported that one scheme was being delivered in relation to bus stops in Kiln Road Thundersley. SA to keep Panel updated on progress.	
	Essex Way junction with Vicarage Hill, Benfleet The Panel noted a report from the Casualty Reduction Team which set out suggested remedial measures to prevent collisions with the wall of a property at this junction. The skid resistance of the carriageway surface around the bend was to be checked by the Road Safety Engineering Team. The outcome would be reported back to the Panel.	SA
	During discussion it was established that a trief kerb along the pavement was not a suitable solution as it would cause more harm to pedestrians and vehicles in the event of a collision. A roundabout was also not suitable given the size of the junction and restricted visibility at the location.

CASTLEPOINT BOROUGH COUNCIL WITH ESSEX COUNTY COUNCIL LOCAL HIGHWAY PANEL – 23rd JANUARY 2018 REPORT 1- 2017/18 APPROVED WORKS PROGRAMME BUDGET SUMMARY

It is envisaged that the 2018/19 Capital budget for the Castle Point LHP will be the same as that in 2017/18 (£228,675), though this will be finalised by ECC at their full Council meeting in February 2018. The Panel will need to review those schemes within the Rolling Programme and agree those for inclusion for delivery in 2018/19.

Members are reminded that the costs supplied are estimates only and there is the possibility that a final scheme cost could change significantly dependant on issues which may arise especially during detailed design and construction. The estimated scheme costs on both the Rolling Programme and the Potential Scheme List have been reviewed and adjusted as necessary to reflect this.

Additionally at this stage, we have not been notified of the Safer Roads schemes that will need to be progressed within the Borough in 2018/19.

Our Safer Roads team are currently preparing their 2018/19 programme with a view to finalising it by the end of January 2018.


