This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Tendring District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

**BY THIS ORDER:**

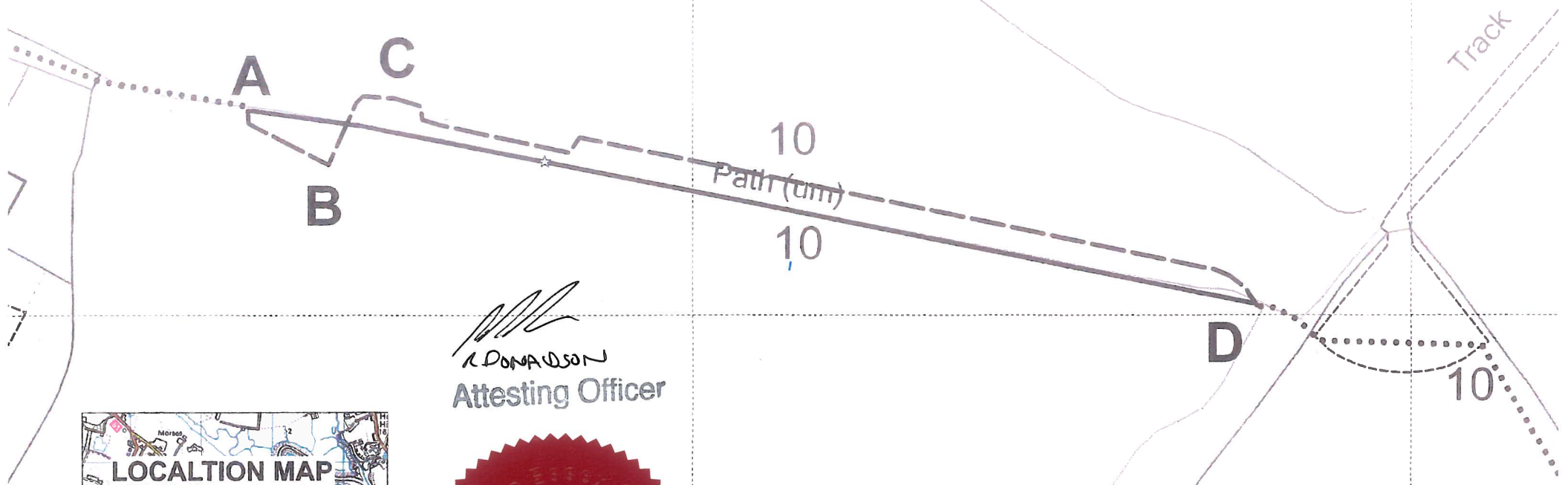
1) The public right of way over the land situated in the parish of Brightlingsea known as Footpath 10 in the District of Tendring and shown by a bold continuous black line on the order map numbered BRIGHT 10A contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 14 days from the date of confirmation of this order.

2) There shall at the end of 14 days from the date of confirmation of this order be a public footpath over land situated in the parish of Brightlingsea known as Footpath 10 in the District of Tendring as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered BRIGHT 10A contained in this order.

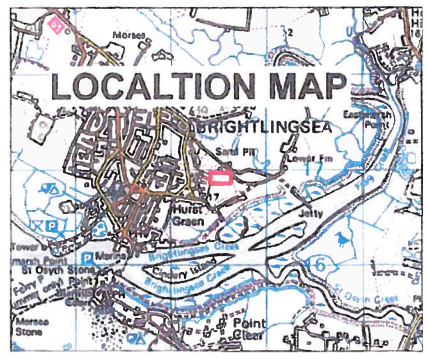


**Plan No. BRIGHT 10 A**

**DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 10 of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 60944,21693 running in an east south easterly direction for a total distance of approximately 142 metres to point **D** at grid reference 60957,21690.

**DESCRIPTION OF SITE OF NEW PATH OR WAY**

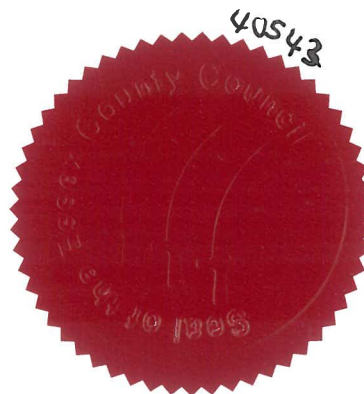
A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in a south then south easterly direction for a distance of approximately 16 metres to point **B** at grid reference 60945, 21692 then in a north easterly direction for a further distance of approximately 14 metres to point **C** at grid reference 60945,21693 then continuing in a generally east south easterly direction for a final distance of approximately 133 metres to the aforementioned point **D** where it continues unaffected.
