This Order is made by the Essex County Council ("the authority") under section 118 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

Braintree District Council have been consulted and have consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Alphamstone known as Footpath 12 Alphamstone in the District of Braintree and shown by a bold continuous line on the order map numbered ALPH 12X attached to this order and described in the Schedule to this Order shall be extinguished after 28 days from the date of confirmation of this Order.

SCHEDULE

DESCRIPTION OF SITE OF PATH OR WAY TO BE EXTINGUISHED

The entire length of Footpath 12 Alphamstone shown by a bold black continuous line on the order map starting from point **V** at grid reference 58747,23524 at the highway known as Pebmarsh Road running in a generally north westerly direction through the grounds of the property known as Alphamstone House then in a northerly direction across the field then continuing in a north easterly direction through dense undergrowth then in a north westerly direction for a total distance of approximate 400 metres to point **W** at grid reference 58736,23556 where it connects to Footpath 30.


