This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Colchester Borough Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

**BY THIS ORDER:**

1) The public right of way over the land situated at Copford Hall known as Footpath 10 Copford in the Borough of Colchester and shown by a bold continuous black line on the order map numbered **COP 10B** contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order

2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated at Copford Hall known as Footpath 10 Copford in the Borough of Colchester as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered **COP 10B** contained in this order.

Route to Close A-D

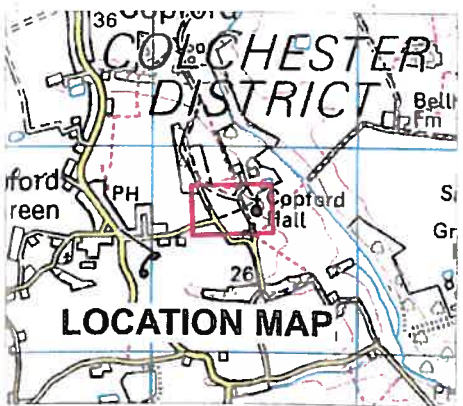
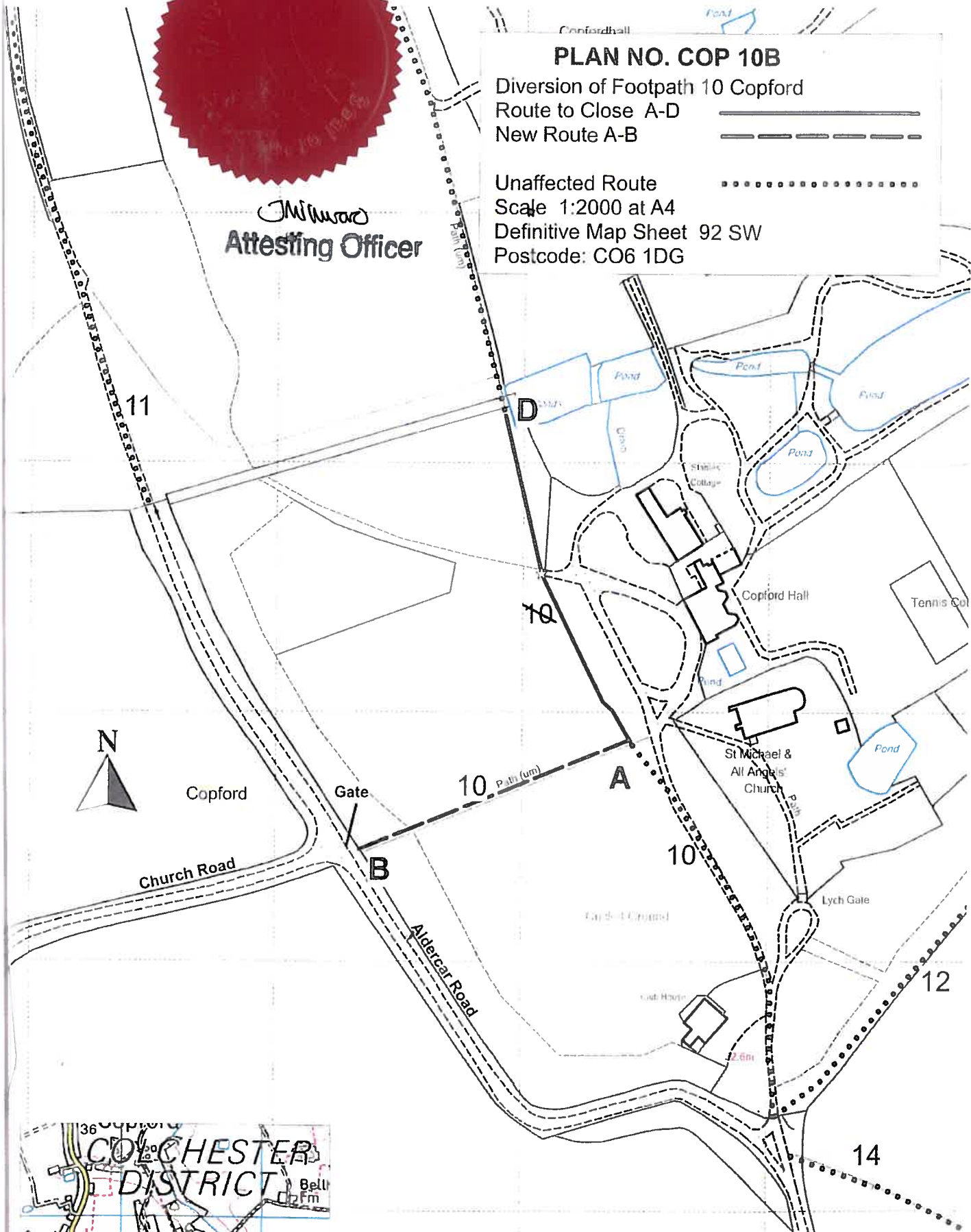
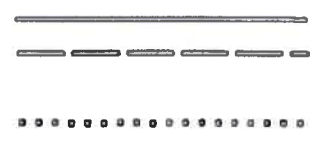
New Route A-B

**DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 10 Copford of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 59344,22268 to the west of St Michael & all Angels Church running in a generally north north westerly direction to the west of Copford Hall for a total distance of approximately 140 metres point **D** at grid reference 59339,22281.

**(PART 2)**

**DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in a west south westerly direction on the north side of the cricket field for a total distance of approximately 117 metres to point **B** at grid reference 59333,22264 where it connects to the highway at the T-junction between Church Road and Aldercar Road.
