This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the way into a fit condition for use by the public.

Uttlesford District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated at Field House known as Bridleway 9 Hatfield Heath in the District of Uttlesford and shown by a bold continuous black line on the order map numbered HHEATH 9A contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.

- 2) There shall at the end of 28 days from the date of confirmation of this order be a public bridleway over land situated at Field House known as Bridleway 9 Hatfield Heath in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered HHEATH 9A contained in this order.

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Bridleway 9 Hatfield Heath of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 55195,21544 on the existing track running in a northerly direction across the garden of Field House for a total distance of approximately 150 metres to point **C** at grid reference 55195,21559.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A bridleway being 3 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in a generally north north westerly direction along the existing track for a distance of approximately 128 metres to point **B** at grid reference 55193,21557 then continuing in a north easterly then northerly then an easterly direction for a final distance of approximately 36 metres to the aforementioned point **C** where it continues unaffected.
