This Order is made by Essex County Council (“the authority”) under section 118 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that the footpath described in paragraph 1 below is not needed for public use.

Chelmsford City Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated west of Penny’s Lane known as Footpath 17 Margarettin in the City of Chelmsford and shown by a bold continuous line on the order map numbered PROW-20-14 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up on confirmation of this order

**DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE EXTINGUISHED**

The entire length of Footpath 17 Margareting of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 56666,20158 where it connects to Penny's Lane running first in a westerly then generally northerly then north westerly direction through property boundaries and across the landscaping, slip roads and carriageways of the A12 dual carriageway for a total distance of approximately 533 metres to point **B** at grid reference 56646,20205 where it meets Ivy Barns Lane.

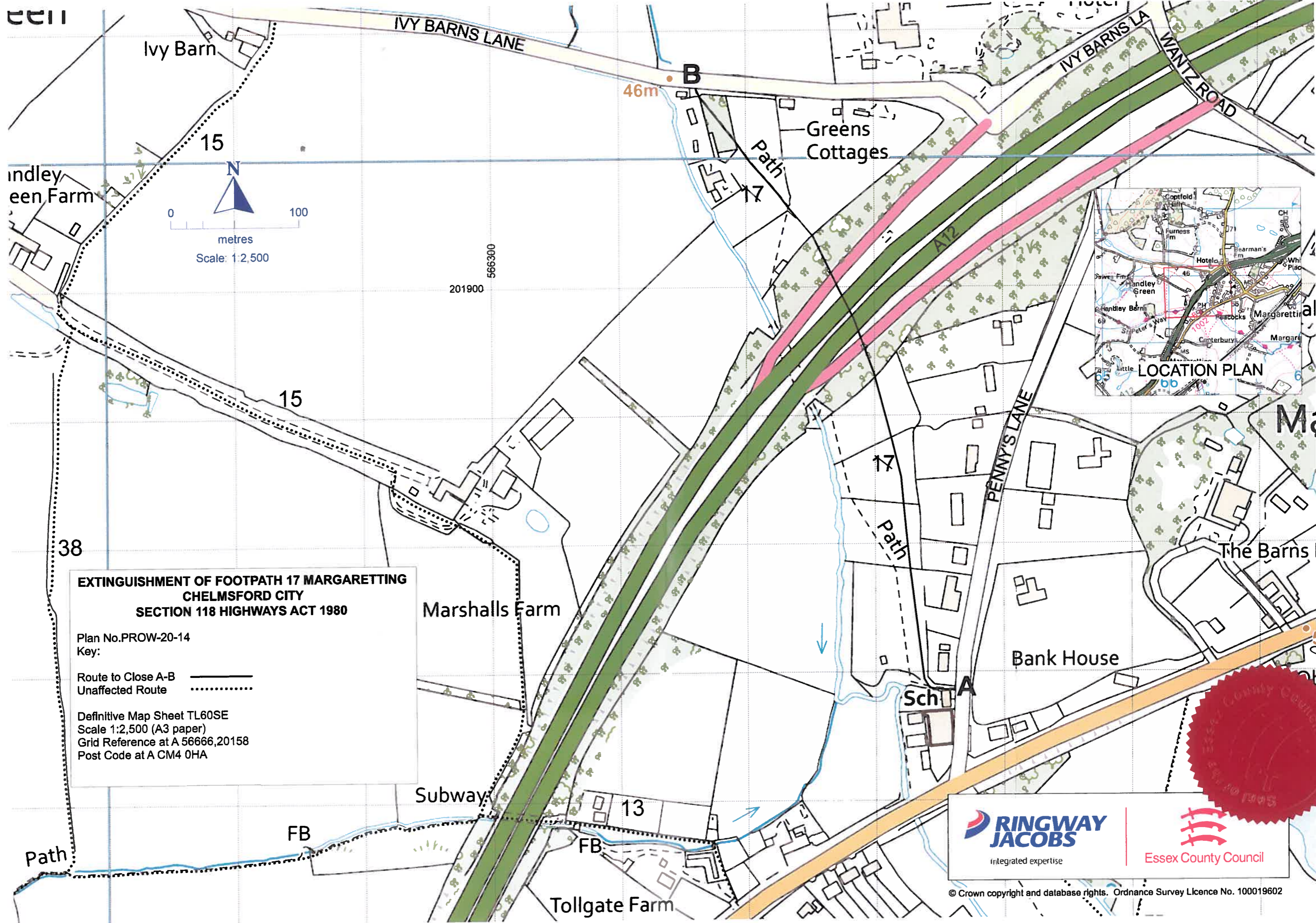
