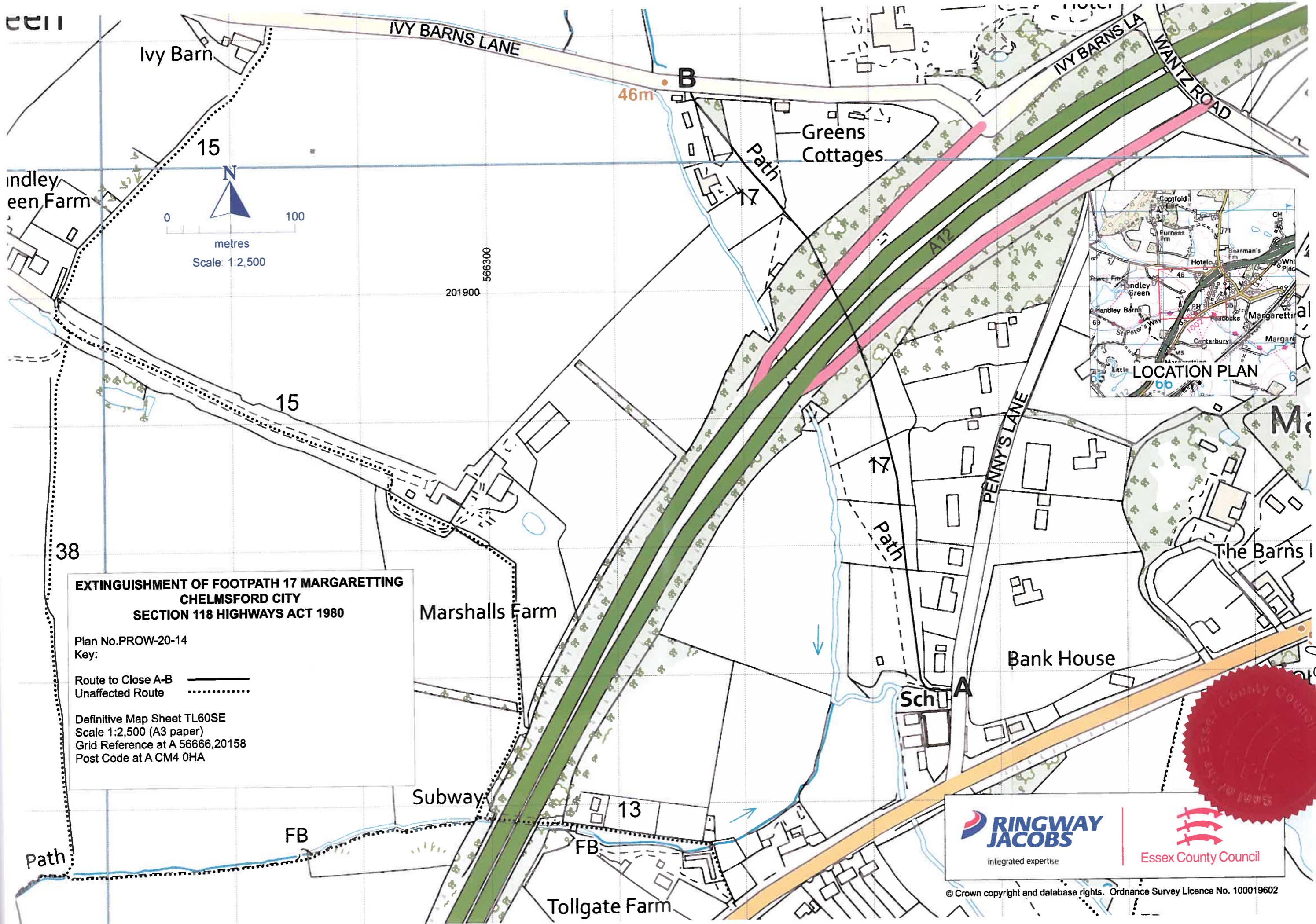
FOOTPATH 17 MARGARETTING

DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE EXTINGUISHED

The entire length of Footpath 17 Margareting of unknown width shown by a bold continuous black line on the order map commencing from point **A** at grid reference 56666,20158 where it connects to Penny's Lane running first in a westerly then generally northerly then north westerly direction through property boundaries and across the landscaping, slip roads and carriageways of the A12 dual carriageway for a total distance of approximately 533 metres to point **B** at grid reference 56646,20205 where it meets Ivy Barns Lane.
