These notices are there to inform the public and are rarely open to challenge or objection. These notices are required by law to alert people to changes and allow them to adjust their travel arrangements. They are almost always placed by Local Authorities, sometimes on behalf of other organisations. Some of the more common notices relate to Temporary Traffic Regulation Orders, Road & Traffic Regulation Act 1984, Traffic Movement and Speed Limits and the Town and Country Planning Act 1990.
