The Essex County Council Definitive Map Modification No. 342 (Braintree District) Order 2006

This Order is made by Essex County Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement for the County of Essex require modification in consequence of the occurrence of events specified in Section 53(3)(a), (ii) and (iii), namely the coming into operation of any enactment, instrument or other event described in the remarks column of the Appendix attached hereto whereby — (ii) a highway shown or required to be shown in the map and statement as a highway of a particular description has ceased to be a highway of that description; or (iii) a new right of way has been created over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

- 1. For the purpose of this Order the relevant date is 10 March 2006.
- 2. The Definitive Map and Statement for the County of Essex shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
- This Order shall take effect on the date it is made and may be cited as the Essex County Council Definitive Map Modification No. 342 (Braintree District) Order 2006.


