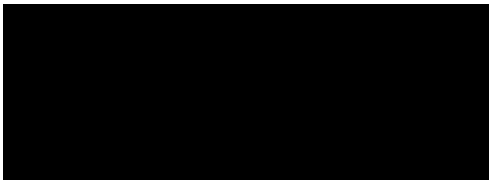

Thank you for your email communicating the Parish Council's response. Don't worry too much re the deadline as that is not so important for the Informal Consultation.

In terms of the Parish Council's response I hope you won't mind if I provide some detail as to the decision making behind the Highway Authority's agreement to process this application and also the criteria of the legislation used.

I would be grateful if you could then share that information with councillors for discussion at your next meeting please.

In terms of the applicable criteria of the legislation a public right of way (PROW) (or as here a section of a PROW) is: 'Where it appears to a council as respects a footpath [bridleway or restricted byway] in their area (other than one which is a trunk road or a special road) that it is expedient that the path or way should be stopped up on the ground that it is not needed for public use.' The key word here being 'needed.'

When we undertook our assessment of this application it was clear that Byways 98 and 100 Wimbish perform the same function in terms of access as the section of footpath to be extinguished with very little divergence in terms of route, and no substantial increase in distance. We purposefully retained a section of Footpath 70 to ensure that connections to Footpath 67 were retained. I should add that we are very circumspect with Public Path Order (PPO) applications to ensure that they meet the criteria of the legislation under which they will be processed.

In light of the availability of alternative nearby PROW, our site visit assessment concluded that the application fully complied with the criteria of the legislation. I believe that due to the proximity of the alternative routes it would be difficult for anyone to substantiate an argument for retention of the section of footpath proposed to be extinguished on the basis that it is 'needed' for public use – this being the relevant legal test.

The Parish Council may/may not be aware, but DEFRA also recently issued official guidance (attached) to order confirming authorities (which includes the County Council and the Planning Inspectorate on behalf of the Secretary of State) to ensure that those authorities give additional consideration where a PROW passes through a (in this case) a 'garden or curtilage of a residential property.' The proposal to extinguish a section of Footpath 70 is applicable to this guidance as sections of it pass through three separate property gardens, making the advice and presumption therein relevant.

Lastly, I need to outline the consequences if the Parish Council were to maintain an objection at the Made Order stage.

I should first say though that it is very likely that we will, after discussions with the applicant, go ahead and make an order despite the objection. It would be difficult for me to make a case for not doing so as the proposal in our view and my experience meets the criteria of the legislation. Consequently it is perfectly reasonable for the applicant to expect Essex County Council as the Order Making Authority (OMA) to stand behind the initial decision to accept the application.

I can advise that the Parish Council were the sole objectors to the Informal Consultation – none of the user groups objected, which I would expect to happen where a PROW is viewed by them as genuinely needed.

If your objection was maintained at the formal, Made Order stage it is highly probable, for the reasons outlined above, that we would proceed with a referral of the order for determination to the Secretary of State in the form of the Planning Inspectorate (PINS). This referral and the time and expense incurred therein cannot be charged to the applicant under the current legislation, so the taxpayer is therefore obliged to absorb the costs of referral.

Because the Parish are a tier of government the determination would automatically be by means of a Public Inquiry. This not only adds considerably to the costs of the referral but can result in a more combative environment and added costs of legal representation etc., which does seem to me to be unnecessary for what in our view, in legislative terms, is a straightforward matter. A PINS Inspector would be operating under the same guidance mentioned above and I am confident that they would conclude the same as the OMA, namely that proposal meets the criteria of the Section 118 Highways Act 1980 legislation. The potential of an award of costs against the Parish Council or other parties (for unreasonable behaviour) is another risk with a PINS referral, which cannot be ruled out especially if an applicant chooses to employ a legal representative who may then look for an award of costs (inc. their time) against a party where unreasonable behaviour at an Inquiry (which could be something as simple as late submission of evidence) occurs.

I appreciate that I have given you and the councillors a lot to read and to consider and I appreciate the time that you all are able to give to do that.

The choice of whether to sustain an objection or not of course lies with the Parish Council and it is right that that is so.

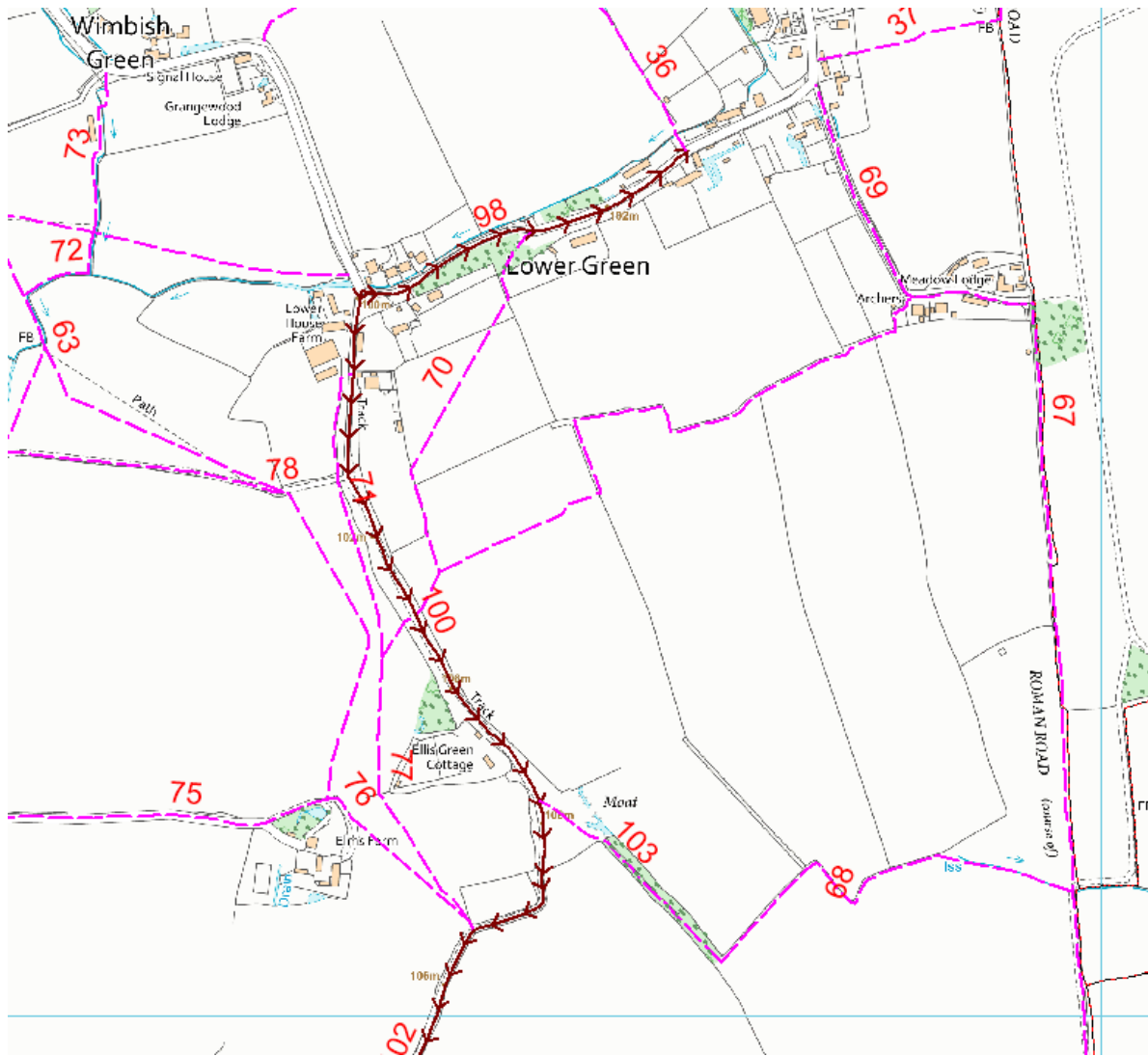
In this case, however, my experience of confirming over a hundred public path orders including a number of those via referrals to PINS and the assessment on site by myself and the area PROW Officer, leads me to conclude that the extinguishment proposal does fully meet the criteria of the legislation and should for that reason be confirmed and it would be remiss of me not to advise that.
