Chelmsford City Council have been consulted as required by section 120(2) of the 1980 Act.

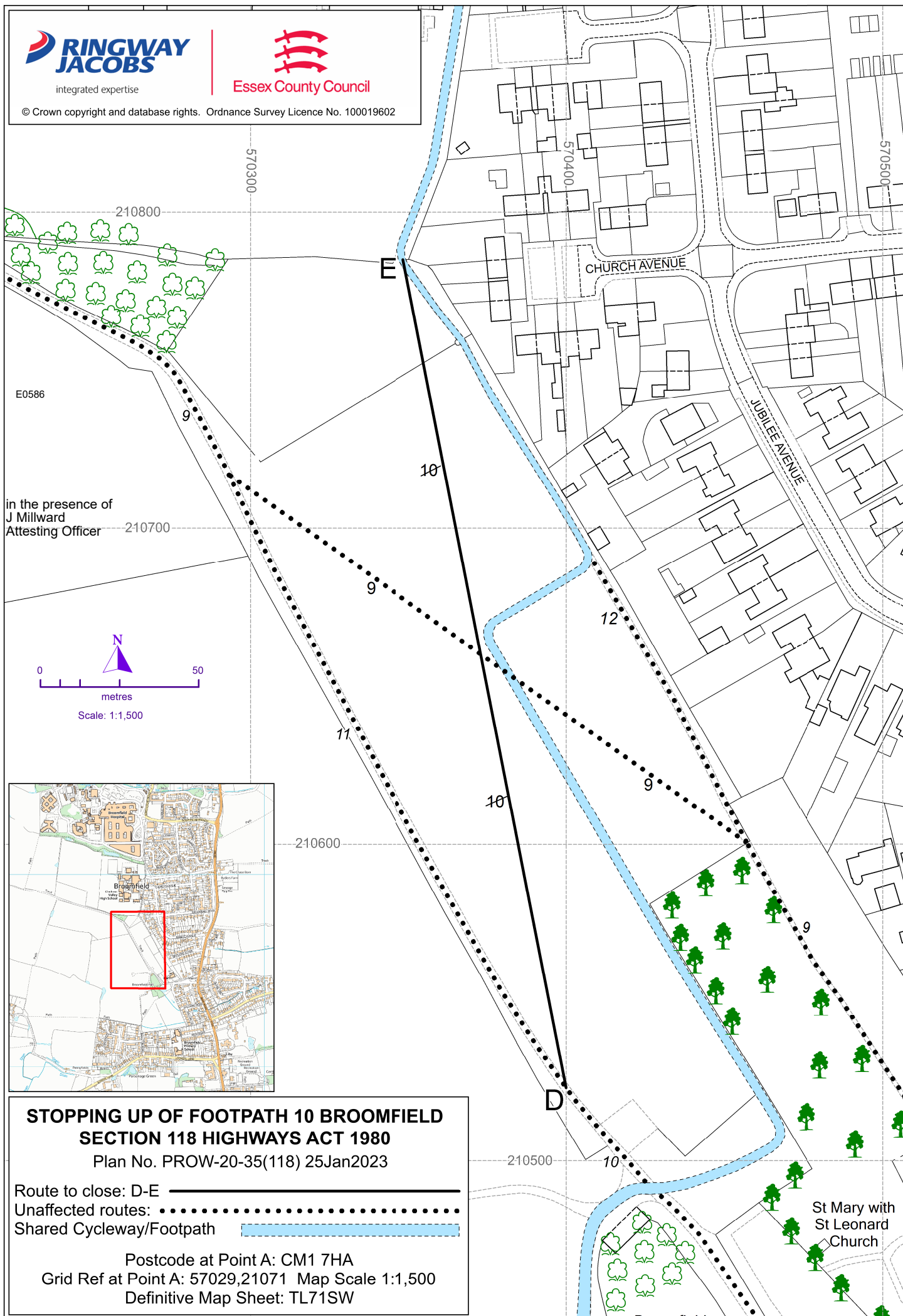
BY THIS ORDER:

The public right of way situated over land north west of St Mary with St Leonard Church known as Footpath 10 Broomfield in the City of Chelmsford and shown by a continuous bold line on the order map PROW-20-35(118) 25Jan2023 contained in this order and described in the Schedule to this order shall be extinguished after 28 days from the date of confirmation of this order.

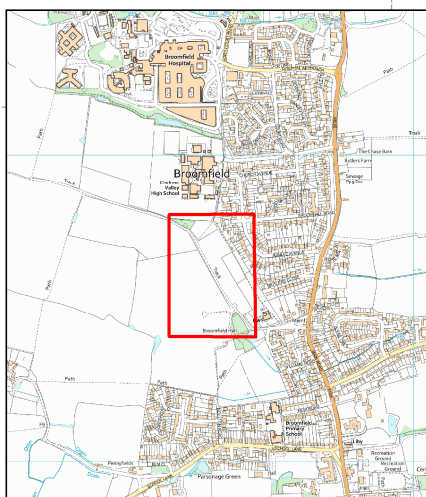
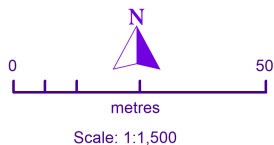
**SCHEDULE**

**DESCRIPTION OF SITE OF PATH OR WAY TO BE EXTINGUISHED**

A part length of Footpath 10 Broomfield of unknown width shown by a continuous bold line on the order map commencing from Point **D** at grid reference 57039,21052 at its connection with Footpath 11 Broomfield north west of St Mary with St Leonard Church proceeding in a north north-westward direction across the crop field then grass area for a total distance of approximately 265 metres to Point **E** at grid reference 57034,21078 at its connection with the new Cycleway/Footpath west of Church Avenue.
