
This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owners of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Uttlesford District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated at Mace Dell known as Footpath 99 Felsted in the District of Uttlesford and shown by a bold continuous black line on the order map numbered PROW 21-11 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 14 days from the date of confirmation of this order.
- 2) There shall at the end of 7 days from the date of confirmation of this order be a public footpath over land situated west of Mace Dell known as Footpath 99 Felsted in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken black line on the order map numbered PROW 21-11 contained in this order.

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 99 Great Dunmow of variable widths shown by a bold continuous black line on the order map commencing from point **A** at grid reference 571837 219481 in a generally south easterly direction for a distance of approximately 28 metres to point **B** at grid reference 571849 219457 then continuing in a south south westerly direction for a final distance of approximately 7 metres to point **C** at grid reference 571847 219450.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 1.2 metres in width shown by a bold broken black line on the order map commencing at the aforementioned point **A** running in a generally southerly direction for a distance of approximately 28 metres to point **D** at grid reference 571841 219454 then continuing in a south easterly direction for a final distance of approximately 6 metres to the aforementioned point **C**.
