
This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Tendring District Council have been consulted as required by section 120(2) of the 1980 Act.

## BY THIS ORDER:

- 1) The public right of way over the land situated south of The Street and west of Mumfords Lane in Kirby Le Soken known as Footpath 18 Frinton and Walton in the District of Tendring and shown by a bold continuous line on the order map numbered PROW-22-37 rev.09.02.23 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of The Street and west of Mumfords Lane in Kirby Le Soken known as Footpath 18 Frinton and Walton in the District of Tendring as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-22-37 rev.09.02.23 contained in this order.



#### **SCHEDULE**

## (PART 1)

#### DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 18 Frinton and Walton of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 62183,22216 where it connects to The Street running in a south westerly direction across a field for a total distance of approximately 213 metres to point **B** at grid reference 62171,22197 where it meets the field edge by a property boundary fence and continues unaffected.

## (PART 2)

### DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at point **C** at grid reference 62183, 22215 where it connects to The Street approximately 7 metres east of the aforementioned point **A** running in a south south westerly direction along a grass verge for a distance of approximately 112 metres to point **D** at grid reference 62179,22204 where it meets an existing field entrance. The path continues in first a generally westerly then generally south westerly direction into the field then along the field edge for a final distance of approximately 120 metres to the aforementioned point **B** where it continues unaffected.
