1) The entire length of the public right of way over the land situated between Camps Road and Drapers Lane known as Footpath 7 Helions Bumpstead in the District of Braintree and shown by a bold continuous line on the order map numbered PROW-24-04 contained in this order and described in Part 1 of the Schedule to this order shall be extinguished on the date of confirmation of this order.

Unaffected Routes

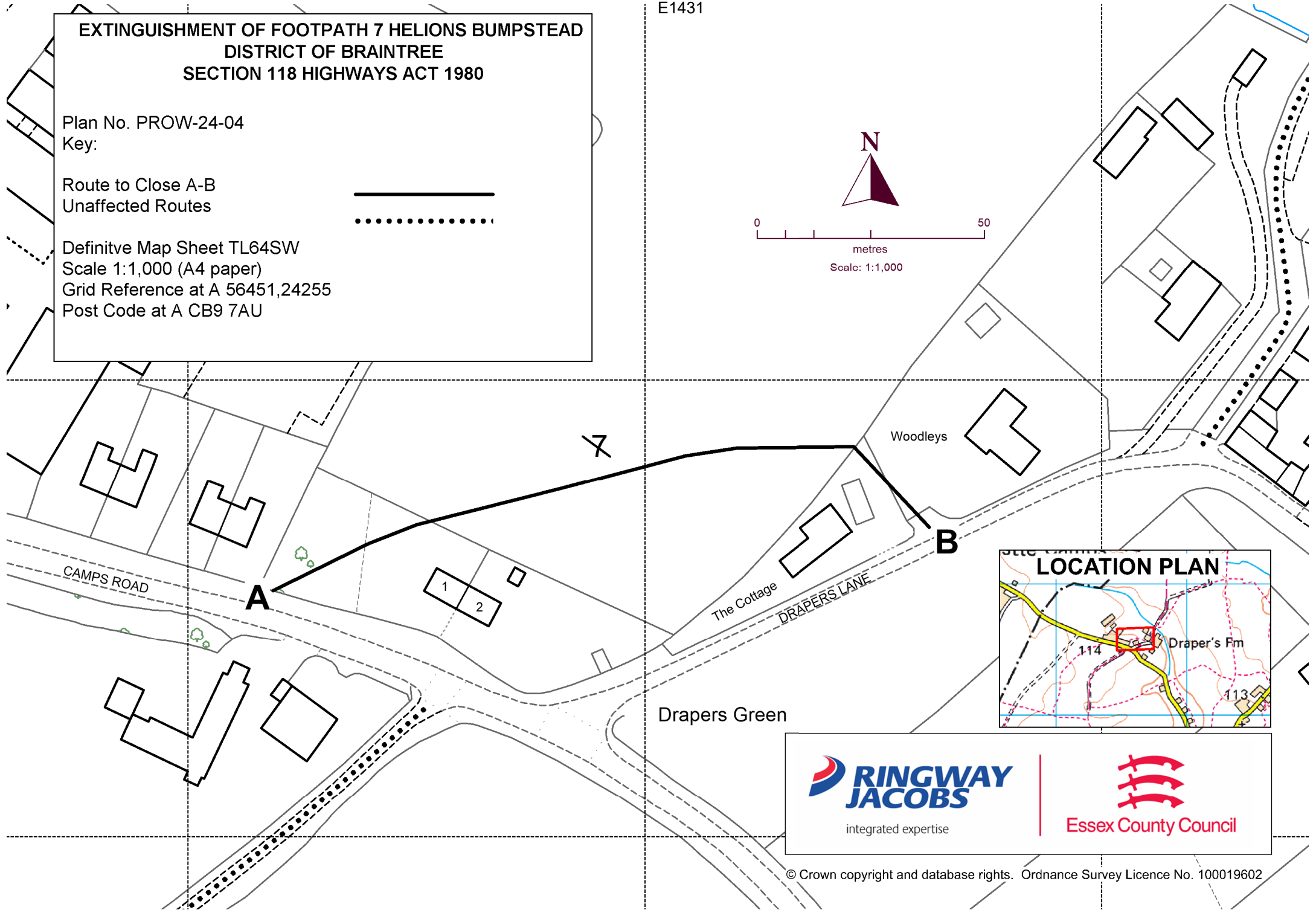
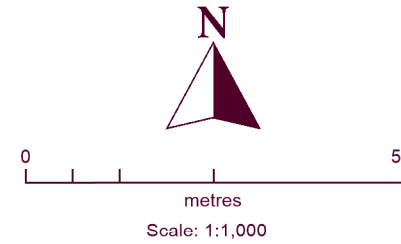

DESCRIPTION OF SITE OF EXISTING PATH OR WAY TO BE EXTINGUISHED

The entire length of Footpath 7 Helions Bumpstead of unknown width shown by a bold continuous line on the order map commencing from point **A** at grid reference 56451,24255 where it connects to Camps Road running in a north easterly then south easterly direction through boundary features gardens and a paddock for a total distance of approximately 156 metres to point **B** at grid reference 56466,24256 where it meets Drapers Lane and terminates.
