This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Uttlesford District Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public right of way over the land situated south of Poplar Road known as Footpath 92 High Easter in the District of Uttlesford and shown by a bold continuous line on the order map numbered PROW-25-08 rev.22.09.25 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south of Poplar Road known as Footpath 92 High Easter in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-25-08 rev.22.09.25 contained in this order.
- 3) The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

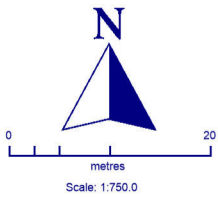

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 92 High Easter being 2 metres in width shown by a bold continuous line on the order map commencing from point **A** at grid reference 56280,21677 located where a farm entrance meets Poplar Road running in a generally southerly then south easterly direction across the corner of a barn building through a horse walker and within a paddock for a total distance of approximately 105 metres to point **B** at grid reference 56283,21667 where it continues unaffected.

(PART 2)

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at point **C** at grid reference 56279,21676 located approximately 7 metres south west of the aforementioned point **A** where it connects to Poplar Road running in a south easterly direction for a distance of approximately 3 metres to point **D** at grid reference 56280,21676 where it continues via an existing pedestrian gate in a south easterly direction between paddock fields for a further distance of approximately 81 metres to point **E** at grid reference 56286,21671 at the corner of the paddock field. The path then continues entering the field via a pedestrian gate and running in a south westerly direction alongside the southern boundary of the paddock field for a final distance of approximately 57 metres to the aforementioned point **B** where it continues unaffected.

(grid reference 56280,21676)</p>	<p>The right of the landowner to install and maintain a pedestrian gate subject to its removal should the limitation become unnecessary whereby an available width shall remain of 2 metres, this being the dedicated width of the path as specified in Part 2 of the Schedule</p>
<p>2. At the point marked E on the order map (PROW-25-08 rev.22.09.25) located at the south east corner of a paddock field. (grid reference 56286,21671)</p>	<p>The right of the landowner to install and maintain a pedestrian gate subject to its removal should the limitation become unnecessary whereby an available width shall remain of 2 metres, this being the dedicated width of the path as specified in Part 2 of the Schedule</p>


