**NOTICE OF CONFIRMATION OF AN ORDER
HIGHWAYS ACT 1980
ESSEX COUNTY COUNCIL
PUBLIC PATH DIVERSION ORDER 2023
FOOTPATH 4 HIGH EASTER**

On 24 February 2023 Essex County Council confirmed the above order made under section 119 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map is to divert a part length of Footpath 4 High Easter commencing from the point where it connects to Footpath 8 High Easter running in a south westerly direction across fields through hedges and buildings for a distance of 213 metres to a point south west of some ponds then continuing in first an east south easterly then south easterly then finally east south easterly direction on the northern side of a hedge boundary for a final distance of 214 metres to a field boundary where it continues unaffected, to an alternative route 2 meters in width commencing from the aforementioned field boundary point running in a north westerly then north easterly then north then north westerly then east north easterly direction around the edge of fields and the edge of a pond for a distance of 278 metres to a point at the field edge where it continues in a north westerly then northerly then westerly direction across fields and around a hedge boundary for a final distance of 242 metres to the aforementioned start point where it continues unaffected.

FOOTPATH 8 HIGH EASTER**

On 24 February 2023 Essex County Council confirmed the above order made under section 119 of the Highways Act 1980. The effect of the order as confirmed as shown on the order map is to extinguish the entire length of Footpath 8 High Easter of unknown width commencing from the where it connects to the current route of Footpath 4 High Easter running in a south south westerly direction across a field and between farm buildings for a total distance of 205 metres to the point where it terminates at its connection with the current route of Footpath 4 High Easter to the south east of three ponds.

The alternative route for Footpath 4 will come into force on 24 March 2023 and the old route shall be stopped up with effect from 31 March 2023, and Footpath 8 was stopped up from 24 February 2023, but if a person aggrieved by the orders wants to question their validity, or that of any provision contained in them, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Orders, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 9 March 2023 make an application to the High Court.
