FOOTPATH 33 HIGH ONGAR AND FOOTPATH 11 BLACKMORE

This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owners of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the line of the paths should be diverted.

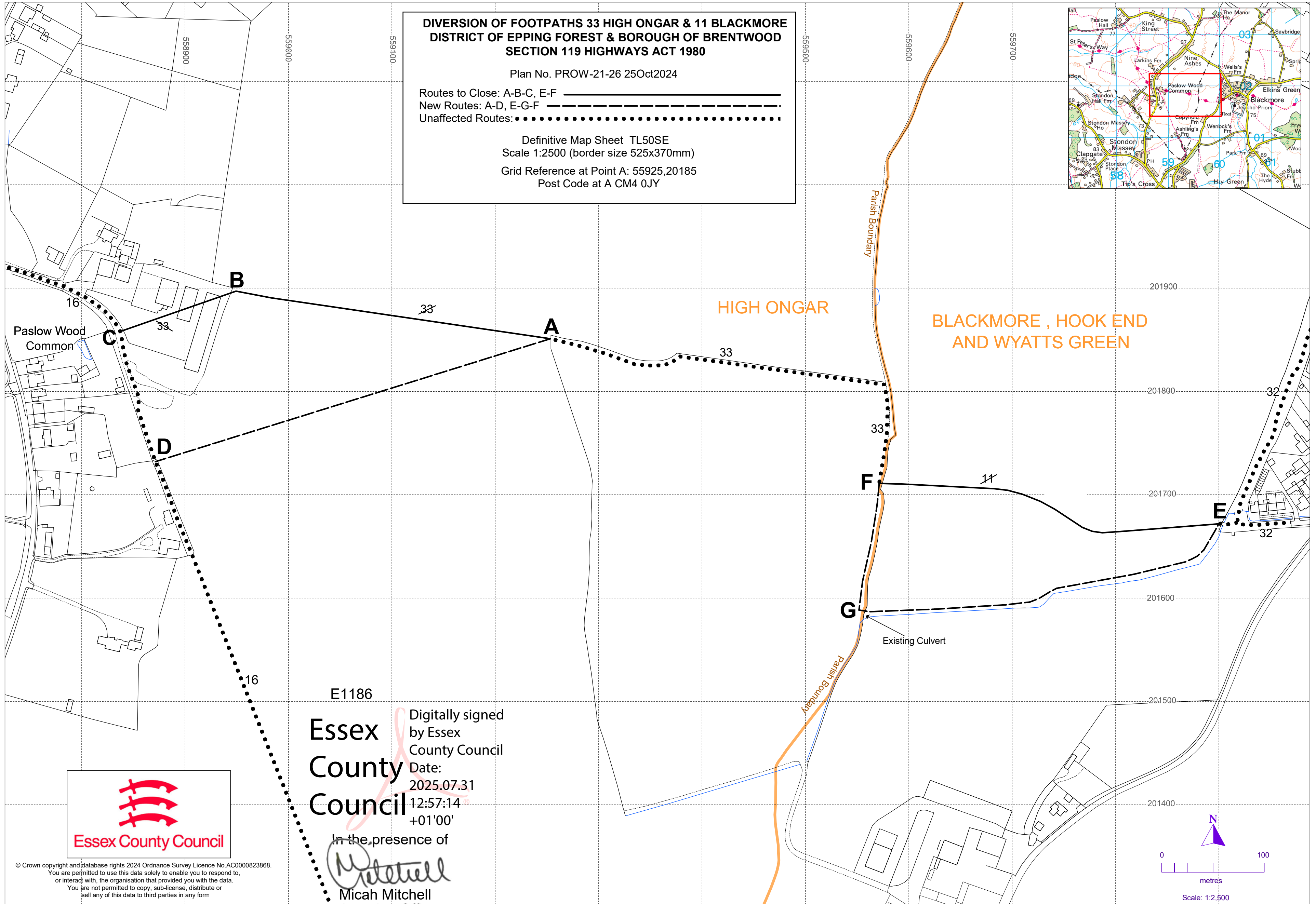
Founthill Paslow Ltd has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the paths into a fit condition for use by the public.

Epping Forest District Council and Brentwood Borough Council have been consulted as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

- 1) The public rights of way over the land situated east of Paslow Wood Common known as Footpath 33 High Ongar in the Parish of High Ongar in the District of Epping Forest and Footpath 11 Blackmore in the Parish of Blackmore Hook End and Wyatts Green in the Borough of Brentwood as shown by bold continuous black lines on the order map numbered PROW-21-26 25Oct2024 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) Notwithstanding this order UK Power Networks shall have the same rights of access to apparatus they once had prior to the confirmation of this order.
- 3) There shall at the end of 28 days from the date of confirmation of this order be public footpaths over land situated east of Paslow Wood Common that will be known as Footpath 33 High Ongar in the Parish of High Ongar in the District of Epping Forest, and Footpath 11 Blackmore in the Parish of Blackmore, Hook End and Wyatts Green in the Borough of Brentwood and described in Part 2 of the Schedule as shown by a bold broken black line on the order map numbered PROW-21-26 25Oct2024 contained in this order.

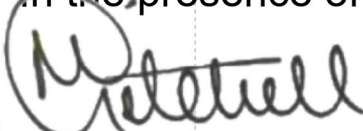

SCHEDULE

(PART 1)

DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS

Footpath 33 High Ongar: A-B-C

A part length of Footpath 33 High Ongar of unknown width shown by a bold continuous black line on the order map commencing from Point **A** at grid reference 55925,20185 at the field edge approximately 325 metres west of the High Ongar with Blackmore Hook End and Wyatts Green Parish Boundary proceeding in a west north-westward direction across the cultivated field for a distance of approximately 307 metres to point **B** at grid reference 55894,20189 at the field edge adjacent to the new housing development then continuing in a west south-westward direction between the new houses and through the industrial yard for a final distance of approximately 118 metres to point **C** at grid reference 55883,20185 at its junction with Bridleway 16 High Ongar and access track to Nine Ashes Road.

Footpath 11 Blackmore: E-F

A part length of Footpath 11 Blackmore of unknown width shown by a bold continuous black line on the order map commencing from Point **E** at grid reference 55990,20167 at the field edge approximately 15 metres west of its junction with Bridleway 32 Blackmore west of Blackmore Road proceeding in a general westward direction across the cultivated field for a total distance of approximately 340 metres to Point **F** at grid reference 55957,20171 at its connection with Footpath 33 High Ongar on the western side of the ditch.

DESCRIPTION OF SITE OF NEW PATHS OR WAYS

Diverted route of Footpath 33 High Ongar: A-D

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing from the aforementioned Point **A** west of the High Ongar with Blackmore Hook End and Wyatts Green Parish Boundary proceeding in a south westward direction across the cultivated field for a total distance of approximately 400 metres to Point **D** at grid reference 55887,20173 at the field edge and connection with Bridleway 16 High Ongar south east of Paslow Wood Common.

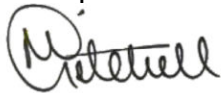
Diverted route of Footpath 11 Blackmore: E-G-F

A footpath being 2 metres in width shown by a bold broken black line on the order map commencing from the aforementioned Point **E** west of Bridleway 32 Blackmore proceeding in a general west south-westward direction at the field edge on the northern side of the hedge/ditch for a distance of approximately 371 metres to Point **G** at grid reference 55955,20158 at the field edge on the western side of the existing culvert then continuing in a northward direction on the western side of the ditch for a final distance of approximately 124 metres to the aforementioned Point **F** connecting with the unaffected part of Footpath 33 High Ongar.

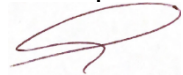
