
Basildon District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Chase Farm Little Burstead known as Footpath 53 in the parish of Little Burstead in the Borough of Basildon and shown by a continuous bold line on the order map numbered PROW-18-34(2) 17Aug2022 attached to this order and described in the Schedule to this order shall be extinguished after 28 days from the date of confirmation of this order.


**SCHEDULE**

The entire length of Footpath 53 Little Burstead of unknown width shown by a continuous bold line on the order map commencing from point **A** at grid reference 56631,19149 at its junction with Footpath 52 Little Burstead east of Chase Farm buildings proceeding in a south westward direction across the agricultural field for a total distance of approximately 361 metres to Point **B** at grid reference 56605,19125 at its junction with Footpath 79 Little Burstead southeast of the farm buildings.
