This Order is made by Essex County Council (“the authority”) under section 26 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that having regard to the matters set out in section 26(1) there is a need for a public footpath over the land to which this order relates, and that it is expedient that the path should be created.

Basildon Borough Council have been consulted as required by section 26(3) of the 1980 Act.

BY THIS ORDER:

1. There shall be at the end of 28 days from the date of confirmation of this order a public footpath over the land at Chase Farm Little Burstead in the Borough of Basildon as described in the Schedule to this order and shown by a bold broken line on the order map numbered PROW-18-34(3) 17Aug2022 attached to this order.

SCHEDULE

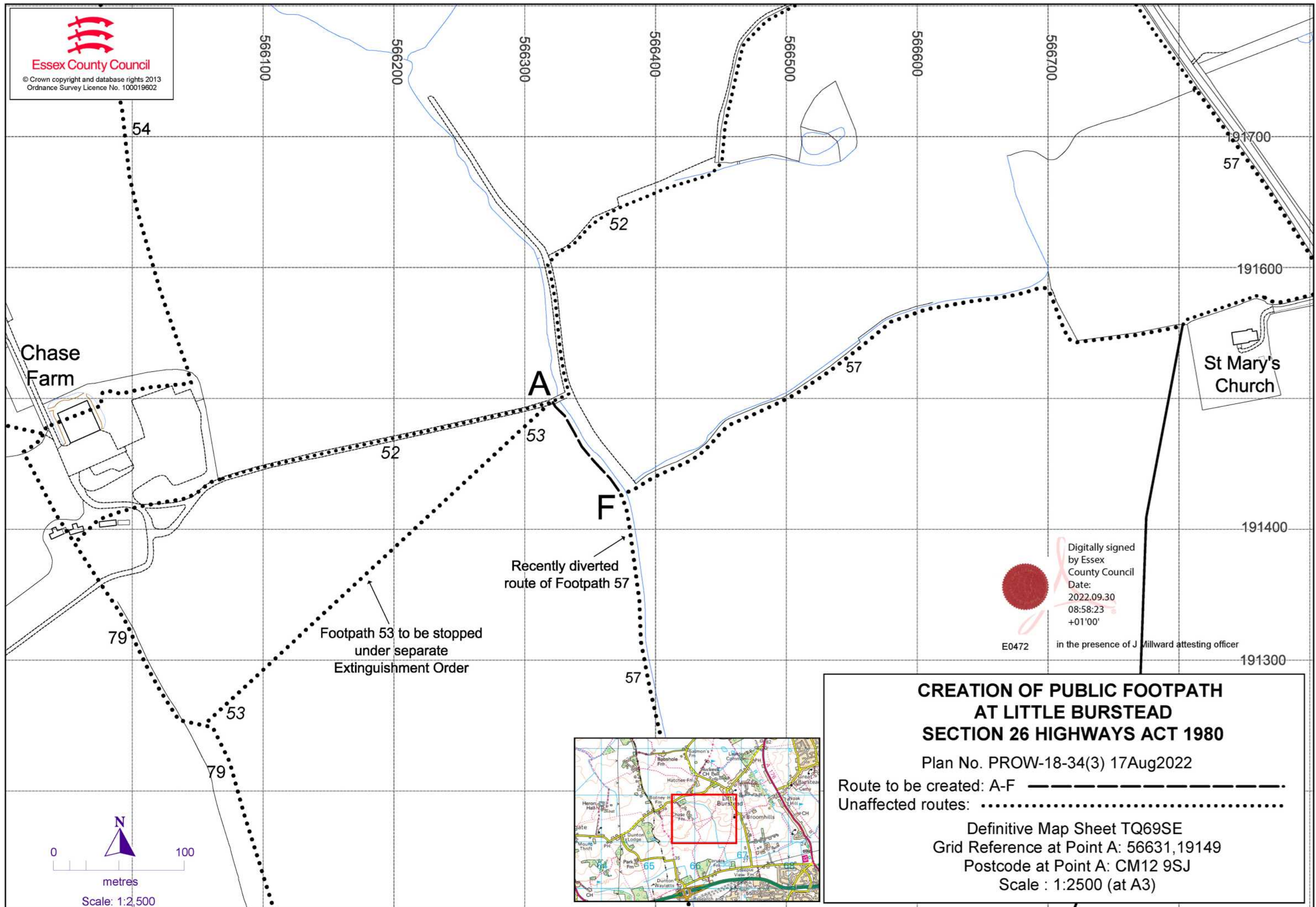
DESCRIPTION OF LAND AND SITE OF NEW PATH OR WAY

A length of footpath being 2 metres in width situated on land at Chase Farm Little Burstead, commencing from Point **A** at grid reference 56631,19149 east of Chase Farm buildings connected to Footpath 52 Little Burstead proceeding in a south eastward direction at the field edge adjacent to and on the western side of the watercourse for a total distance of approximately 89 metres to Point **F** at grid reference 56637,19142 where it joins the newly diverted Footpath 57 Little Burstead.
