This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interest of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses incurred in the order making and bringing the new site of the path into a fit condition for use by the public.

Colchester Borough Council have been consulted.

**BY THIS ORDER:**

- 1) The public right of way over the land situated south west of Keelars Farm within Wivenhoe Quarry known as Footpath 14 Wivenhoe in the Borough of Colchester and shown by a bold continuous line on the order map numbered PROW-22-27 rev.22.09.22 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
- 2) There shall at the end of 28 days from the date of confirmation of this order be a public footpath over land situated south west of Keelars Farm within Wivenhoe Quarry known as Footpath 14 Wivenhoe in the Borough of Colchester as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-22-27 rev.22.09.22 contained in this order.

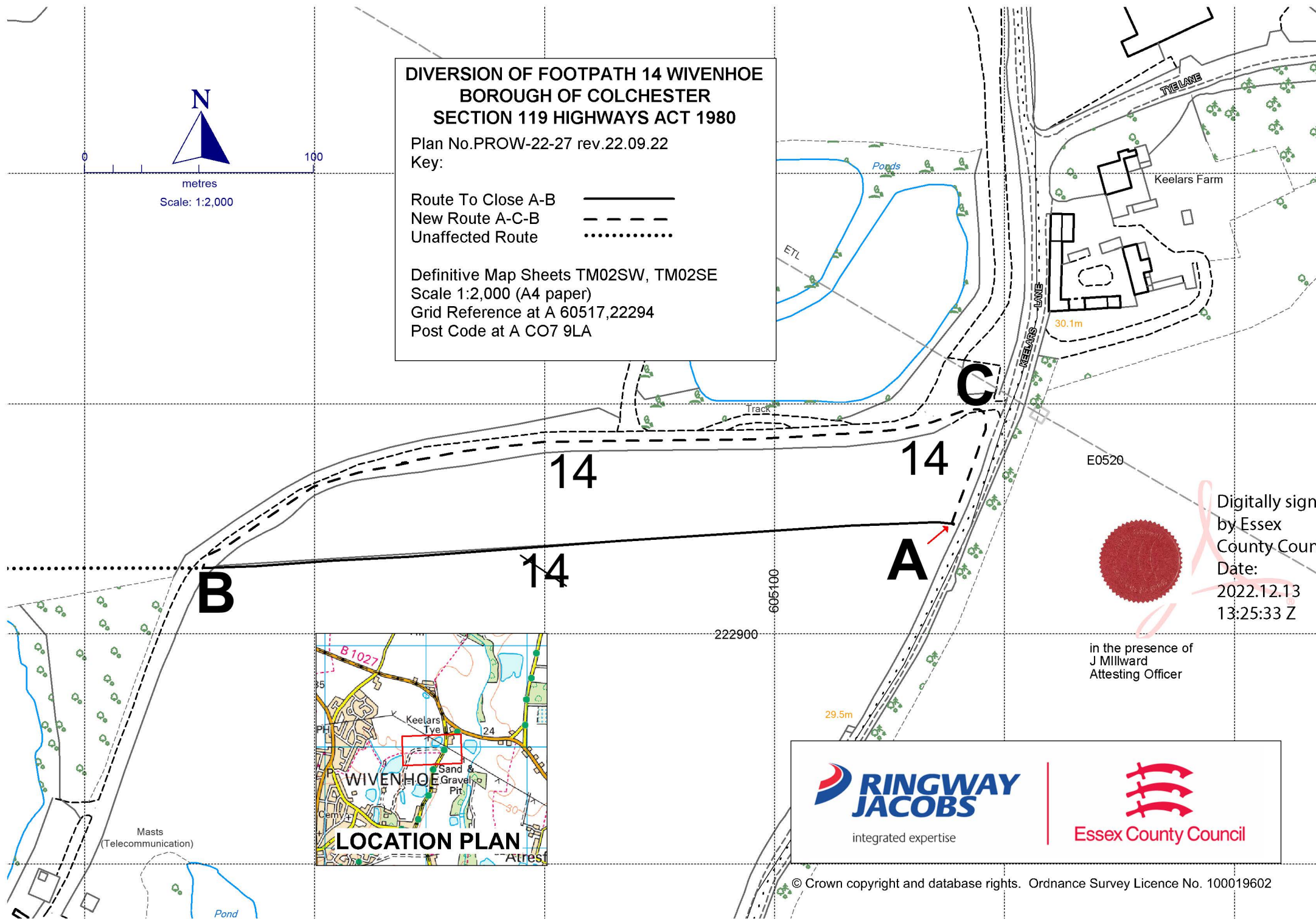

## **SCHEDULE**

### **(PART 1)**

#### **DESCRIPTION OF SITE OF EXISTING PATH OR WAY**

A part length of Footpath 14 of not less than 1.8 metres width shown by a bold continuous line on the order map commencing from point **A** at grid reference 60517,22294 where it meets Keelars Lane running in a generally westerly direction alongside a pond for a total distance of approximately 325 metres to point **B** at grid reference 60485,22293 where it meets the old haul road and continues unaffected.

### **(PART 2)**

#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing at the aforementioned point **A** running in a north north easterly direction along the field edge for a distance of approximately 51 metres to point **C** at grid reference 60519,22299 where it joins the old haul road and runs in a generally westerly then south westerly direction along the old haul road for a final distance of approximately 349 metres to the aforementioned point **B** where it continues unaffected.
