## TENDRING DISTRICT COUNCIL NOTICE OF CONFIRMATION OF AN ORDER TOWN & COUNTRY PLANNING ACT SECTION 257 FOOTPATH 20 WIX

#### PUBLIC PATH DIVERSION ORDER 2023

The above Order, confirmed on 4 April, 2023 under section 257 of the Town & Country Planning Act 1990 will divert a part length of Footpath 20 in the parish of Wix.

Tendring District Council Planning granted application 19/01472/FUL, approved 12.12.2019, to facilitate proposed new holiday accommodation, amendments to use of former workshop building previously approved for holiday accommodation, which necessitates the re-routing of the footpath.

A part length of footpath 20 commencing from a point south of the carriageway known as Oakley Road and running in a south westerly direction along the farm access drive for a distance of 88 metres to a point located north of a pond running in first a south easterly then south westerly then finally south easterly direction for a distance of 75 metres through the business grounds and garden area to a point where it meets the field edge and continues unaffected, to an alternative route 1.1 metres in width commencing at a gap alongside a gate by the carriageway known as Oakley Road 102 metres south west of the aforementioned start point continuing immediately after the gap at a width of 2 metres and running in a south westerly direction along a farm track for a distance of 139 metres to the aforementioned end point where it continues unaffected.
