ESSEX COUNTY COUNCIL FOOTPATH 17 [part] BROOMFIELD PUBLIC PATH DIVERSION ORDER 2002

This Order is made by Essex County Council (“the authority”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that in the interests of the public and of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

Essex County Council has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Chelmsford Borough Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situate at Broomfield adjacent to Mill Lane and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 14 days from the date of confirmation of this Order
2. There shall at the end of 14 days from the date of confirmation of this Order be an alternative public footpath over the land situate at Broomfield as described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATHS

A part length of footpath 17 in Broomfield of unknown width shown by a bold continuous line commencing at point A on the said map at grid reference 71081010 running in a north easterly direction for a total distance of 266 metres through point B to point C at grid reference 71331017

PART 2

DESCRIPTION OF SITE OF NEW PATH

A route 1.5 metres in width shown by a bold broken line on the said map commencing from the aforementioned point A running in a north easterly direction for a distance of 102 metres to point E at grid reference 71181012 then northwards for a distance of 28 metres to point F at grid reference 71181015 then north easterly to point G at grid reference 71101016 then finally in an easterly direction for a distance of 148 metres to the aforementioned point C where the footpath continues as footpath 17 northwards to join Mill Lane

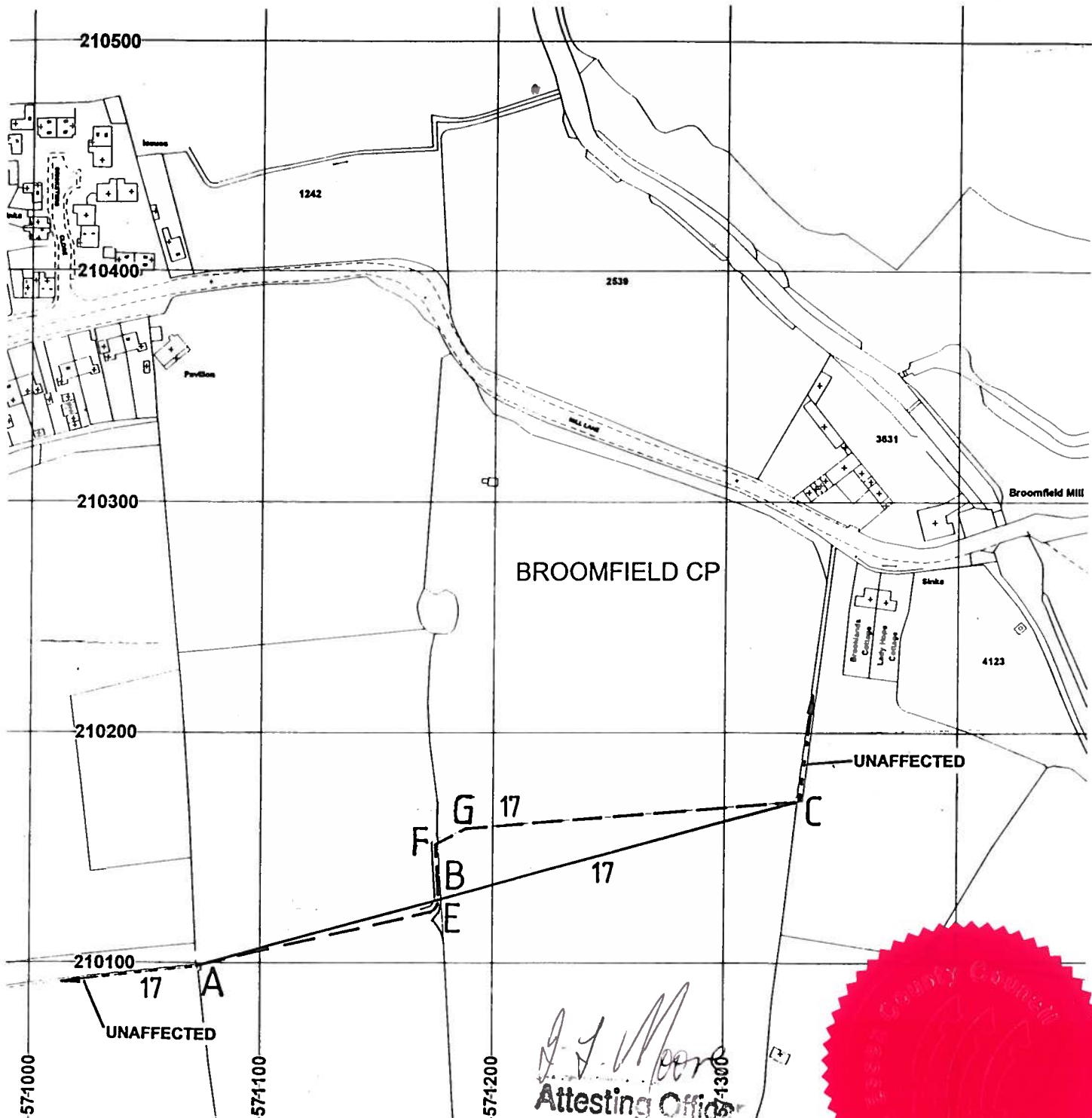

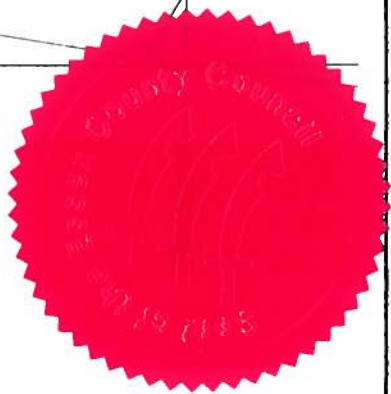
