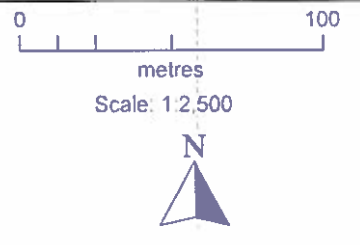
This order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interest of the owner of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the line of the paths should be diverted.

Mr P Rutterford has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and has agreed to contribute towards the expenses incurred in the order making and bringing the new site of the paths into a fit condition for use by the public.

Uttlesford District Council have been consulted and have consented to the making of the order as required by section 120(2) of the 1980 Act.

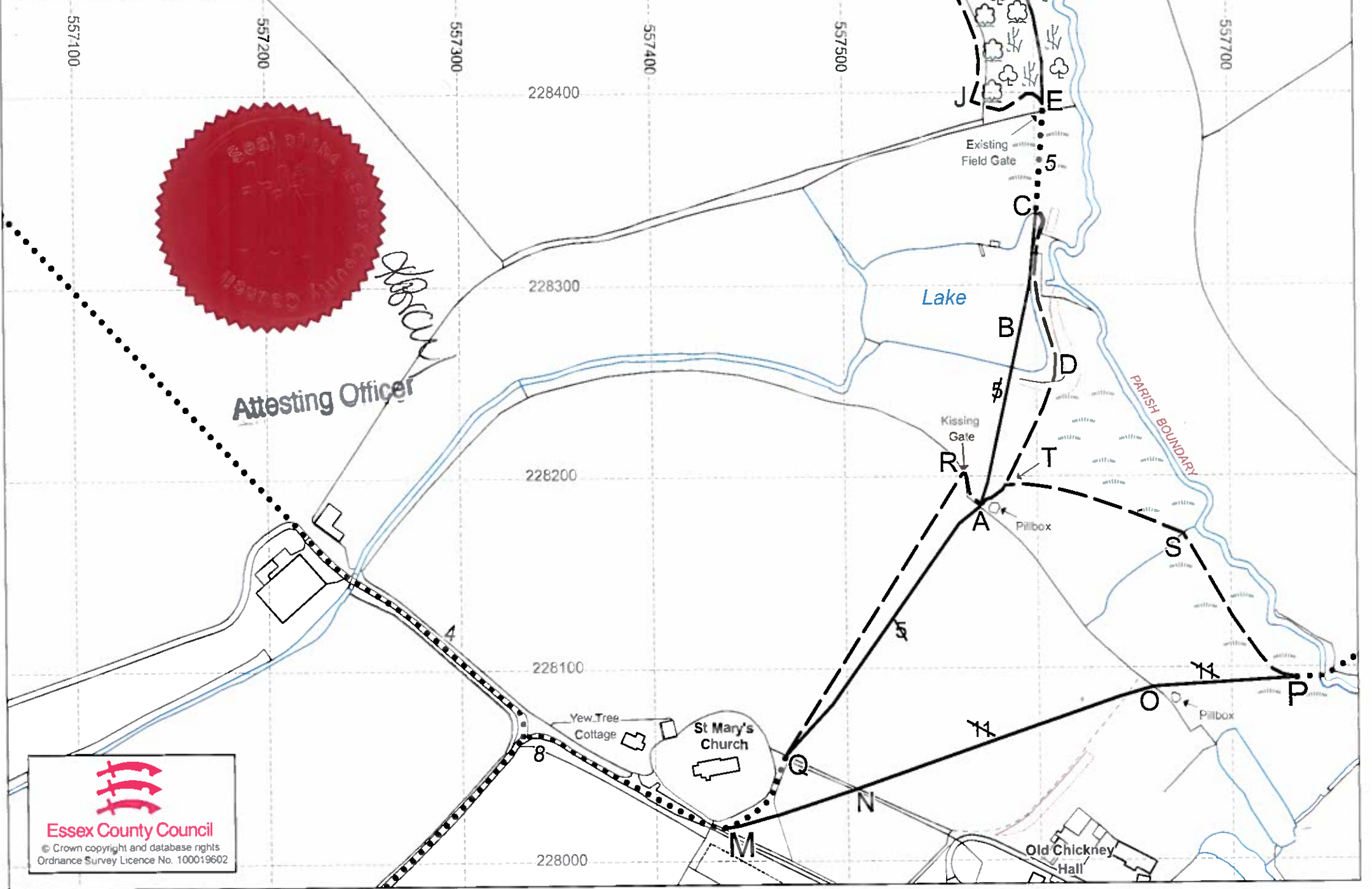
**BY THIS ORDER:**

1. The public rights of way over land situated north of Old Chickney Hall CM6 2BY known as Footpaths 5 and 11 Chickney in the District of Uttlesford and shown by a bold continuous line on the order map numbered PROW-18-10 rev06Dec2019 contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 35 days from the date of confirmation of this order.
2. There shall at the end of 28 days from the date of confirmation of this order be public footpaths over land situated north of Old Chickney Hall CM6 2BY in the District of Uttlesford as described in Part 2 of the Schedule and shown by a bold broken line on the order map numbered PROW-18-10 rev06Dec2019 contained in this order.
3. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **[PART 1]**

#### **DESCRIPTION OF SITE OF EXISTING PATHS OR WAYS**

##### **Q-A-B-C**

A part length of Footpath 5 Chickney of unknown width shown by a bold continuous line on the order map commencing from Point **Q** at the edge of the arable field east of St Mary's Church at grid reference 55746,22805, proceeding north eastwards across the field for a distance of approximately 165 meters to Point **A** at grid reference 55757,22818 at the foot of the earth embankment on the northern side of the field fence boundary, then continuing north-northeast through the rough meadow grassland and across the corner of the lake via Point **B** at grid reference 55759,22827 for a final distance of approximately 155 metres to Point **C** at grid reference 55760,22833 beside the lake at its north eastern corner.

##### **E-F-G-H**

A further part length of Footpath 5 Chickney of undefined width shown by a bold continuous line on the order map commencing from Point **E** at grid reference 55760,22839 approximately 5 metres north of the field gate in the small copse north of the lake, proceeding in a general north westward direction for a distance of approximately 270 metres through the copse via Point **F** at grid reference 55757,22848 to Point **G** at grid reference 55746,22861 at the field edge north of the copse. The path continues across the corner of the arable field in a north westward direction for a final distance of approximately 465 metres to Point **H** at grid reference 55718,22897 at the field edge adjacent to the brook.

##### **M-N-O-P**

A part length of Footpath 11 Chickney of undefined width shown by a bold continuous line on the order map commencing from Point **M** at grid reference 55743,22801 at its junction with Footpaths 5 and 8 Chickney adjacent to the southern side of St Mary's Church hedge boundary, proceeding in an east-northeast direction across the grass area for a distance of approximately 70 metres to Point **N** at grid reference 55750,22803 at the hedge boundary, continuing east-northeast across the arable field for a further distance of approximately 162 metres to Point **O** at grid reference 55765,22809 in the corner of the scrub area adjacent to the meadow, the path then heads eastward across the meadow for a final distance of approximately

73 meters to Point P at grid reference 55773,22809 approximately 12 metres west of the brook where it continues unaffected across the watercourse.

[PART 2]

DESCRIPTION OF SITE OF NEW PATHS OR WAYS

**Q-R-A-T-D-C**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned Point Q at the edge of the arable field, proceeding north eastwards across the field for a distance of approximately 174 meters to the field edge fence boundary at Point R at grid reference 55756,22820, continuing on the eastern side of the field fence boundary in a south eastward direction for a distance of approximately 20 metres to the aforementioned Point A at the foot of the earth banking. The path continues initially north eastwards passing west of the pillbox then north-northeast across the meadow via Point T at grid reference 55758,22819 for a further distance of approximately 90 meters to Point D at grid reference 55760,22826 beside the south eastern corner of the lake, then generally northward adjacent to the eastern side of the lake for a final distance of approximately 80 metres to the aforementioned Point C at the north eastern corner of the lake.

**E-J-K-G-L-H**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned Point E north of the field gate in the small copse, proceeding in a meandering manner generally westward through the copse for a distance of approximately 42 metres to Point J at grid reference 55756,22839 in the field corner on the western side of the copse. The path then continues in a general north westward direction at the field edge on the western side of the copse for a further distance of approximately 243 metres to Point K at grid reference 55744,22859 at the north western corner of the copse, then continuing north east for a further distance of approximately 28 meters at the field edge to the aforementioned Point G, finally proceeding northward then north westward at the field edge for a final distance of approximately 500 metres via Point L at grid reference 55747,22868 to the aforementioned Point H adjacent to the brook.

**P-S-T**

A footpath being 2 metres in width shown by a bold broken line on the order map commencing from the aforementioned Point P in the meadow west of the brook,

proceeding north westward across the meadow for a distance of approximately 97 metres to Point S at grid reference 55767,22816 approximately 10 metres west of the brook, the path then heads in a west north-westward direction across the meadow for a final distance of approximately 96 metres to connect to the diverted section of Footpath 5 Chickney at the aforementioned Point T approximately 10 metres north east of the pillbox.

At the point marked R on the order Map (PROW-18-10 rev06Dec2019) located in the fence boundary at grid reference 55756,22820.</p>	<p>The right of the landowner to erect and maintain a kissing gate subject to its removal should the management of livestock cease in the meadow to which the gate is preventing the egress of animals, whereby a gap shall remain of 2 metres, this being the dedicated width of the path as specified in Part 2 of the Schedule.</p>
