

Public notice

The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.23) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

Effect of the order:

1. To revoke a section of 'Permit Holders Only C2, Mon-Sat 8am-6pm' to implement 'Disabled Badge Holders Only' bay on the following length of road in the Borough of Colchester:

Road	Description
Kendall Road, Colchester	NORTH SIDE: From a point approx. 30 metres east of its junction with Winnock Road, eastwards for a distance of approx. 5.2 metres. Substitute Tile ref: TM000 245 revision (rev) 1 to 2

2. To revoke a section of 'Permit Parking Area B1' to implement 'Disabled Badge Holders Only' bay on the following length of road in the Borough of Colchester:

Road	Description
Beaconsfield Avenue, Colchester	SOUTH-WEST SIDE: From the common boundary of property No. 24 and 26 Beaconsfield Avenue, south-eastwards for approx. 5.5 metres. Substitute Tile ref: TL990 245 revision 1 to 2

3. To revoke a section of 'Resident Permit Parking Area C1' to implement 'Disabled Badge Holders' bay on the following length of road in the Borough of Colchester:

Road	Description
Portland Road, Colchester	WEST SIDE: From a point approx. 10.4 metres north of its junction with Cromwell Road, northwards for a distance of approx. 5 metres. Substitute Tile ref: TL995 245 revision 0 to 1

4. Upgrade of 'Advisory Bay' to 'Disabled Badge Holders' bay on the following length of road in the Borough of Colchester:

Road	Description
Myrtle Grove, Colchester	WEST SIDE: From the northern boundary of property No.16 Myrtle Grove, south-westwards approx. 7.2 metres, then south-westwards for approx. 3 metres (northern most echelon bay fronting property No.18 Myrtle Grove) Substitute Tile ref: TM000 242 revision 0 to 1 and TM005 242 rev 2 to 3

This Order will be incorporated into The Essex County Council (Colchester Borough) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile numbers TL995 245, TM000 242 revision (rev) 0 to 1, TM000 245, TL990 245 rev 1 to 2, and TM005 242 rev 2 to 3.
