

**The Essex County Council (Byway 13, Black Notley) (Seasonal Prohibition Of Driving) Order 20\*\***

The Essex County Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3) and 3(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III to Schedule 9 to the Act, hereby makes the following Order:-

1. This order shall come into operation on .....and may be cited as the Essex County Council (Byway 13, Black Notley) (Seasonal Prohibition of Driving) Order 20\*\*.
2. Save as provided in Article 3 of this Order, no person shall cause any motor vehicle having more than two wheels or with two wheels abreast to proceed in that length of Byway 13, specified in the schedule to this Order during the period 1 November to 31 March.
3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing any motor vehicle to proceed in the length of Byway specified in the schedule to this order if the vehicle:-
  - (a) is being used for conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to those lengths of byway;
  - (b) Is being used for the purpose of agriculture in connection with land adjacent to those byways or in connection with the conveyance or haulage of timber felled upon that land.
  - (c) Is being used for fire brigade, police or ambulance purposes.
  - (d) Is being used in connection with any of the following operations, namely:-
    - (i) building or demolition operations;
    - (ii) the removal of any obstruction to traffic;
    - (iii) the maintenance, improvement or reconstruction of those lengths of road;
    - (iv) the laying, erection, alteration or repair in or on land adjacent to those lengths of road, of any sewer, or main, pipe of apparatus for the supply of water, gas or electricity, or any telegraphic line; or
  - (e) is being used for the service of or contracted to local authority or water authority in pursuance of statutory powers or duties; or
  - (f) Is to be garaged, serviced or repaired at any premises situated on or adjacent to those lengths of byway.

4. 'The Essex County Council (Various Byways, Black Notley) (Seasonal Prohibition of Driving) Order 1996 is hereby revoked.

Byway 13 Black Notley	From a point 100 metres north east of the junction with Mill Lane, adjacent to the property known as Bateman's Farm, in a generally north easterly and northerly direction for a distance of 1040 metres to a point 100 metres south west of Dagnetts Farm.
