## The Essex County Council (Old Road, Harlow) (Prohibition of Motor Vehicles) Order 202\*

The Essex County Council (hereinafter referred to as "The Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 3(2) of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act"), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

- 1. This order shall come into operation on \*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\*\* and may be cited as The Essex County Council (Old Road, Harlow) (Prohibition of Motor Vehicles) Order 202\*.
- 2. Save as provided in Article 3 of this Order, no person shall cause any vehicle to proceed along the lengths of road as specified in the Schedule to this Order.
- 3. Nothing in Article 2 of this Order shall apply so as to prevent any person from causing any vehicle to proceed in any of the roads referred to in that Article, if the vehicle:
  - a) is being used for the purposes of agriculture on those roads or for the conveyance or haulage of timber felled upon that land.
  - b) is being used in connection with any building operation or demolition in or adjacent to the roads, the removal of any obstruction to traffic in those roads, the maintenance, improvement or reconstruction of those roads, or the laying, erection, alteration, or repair in or adjacent to those roads of any sewer or of any main, pipe, or apparatus for the supply of gas, water, or electricity or of any telegraphic line as defined in the Telegraph Act 1878.
  - c) is being used in the service of a local authority in pursuance of statutory powers or duties.
  - d) is being used in an emergency for Fire and Rescue, Police, or Ambulance purposes;
- 4. The Council are satisfied that for avoiding danger to persons or other traffic using the roads to which the Order relates or any other road and for preventing damage to the road or to any buildings on or near it, it is requisite that Section 3(1) of the Act should not apply in relation to this Order.
- 5. The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 6. No Prohibition of Vehicles restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
