

# Public notice

## The Essex County Council (Maldon District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.13) Order 202\*

**Notice is hereby given** that the Essex County Council proposes to make the above Order under S1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended).

**Effect of the order: To Implement:** 'No Waiting at Any Time' restrictions.

Road	Description
Glendale Road	<b>BOTH SIDES</b> From its junction with Marsh Road, south for approximately 10 metres.
Marsh Road	<b>NORTH SIDE</b> (i) From its junction with Thompson Avenue, west for approximately 26 metres. (ii) From its junction with Thompson Avenue, east for approximately 26 metres. <b>SOUTH SIDE</b> (i) From its junction with Glendale Road west for approximately 10 metres. (ii) From its junction with Glendale Road east for approximately 10 metres. (iii) From its junction with The Leas west for approximately 25 metres. (iv) From its junction with The Leas east for approximately 25 metres.
The Leas	<b>BOTH SIDES</b> From its junction with Marsh Road, south for approximately 10 metres.
Thompson Avenue	<b>BOTH SIDES</b> From its junction with Marsh Road, north for approximately 10 metres.

This Order will be incorporated into The Essex County Council (Maldon District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting map tile: TQ950 967 Revision 0 to Revision 1
