

# Public notice

## The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.30) Order 202\*

**Notice is hereby given** that Essex County Council proposes to make the above Order under Sections 1(1), 2(1) to (4), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984.

### Effect of the Order:

1. To revoke the existing 'No Stopping At Any Time - Red Route' restrictions on the following length of road in the District of Tendring as specified:

Road	Description
Stephenson Road, Clacton-on-Sea	<b>SOUTH SIDE:</b> I. From a point approximately 182 metres from its junction with Paxton Road in an easterly direction for an approximate distance of 7.3 metres. II. From a point approximately 201 metres from its junction with Paxton Road in an easterly direction for an approximate distance of 11.9 metres.

2. To introduce 'No Stopping At Any Time – Red Route' restrictions on the following lengths of road in the District of Tendring as specified:

Stephenson Road, Clacton-on-Sea	<b>SOUTH SIDE:</b> I. From a point approximately 197 metres from its junction with Paxton Road in an easterly direction for an approximate distance of 8 metres. II. From a point approximately 222 metres from its junction with Paxton Road in an easterly direction for an approximate distance of 8 metres.
New Access Bellmouth/side Road	<b>BOTH SIDES:</b> From its junction with Stephenson Road southwards for an approximate distance of 4 metres

This Order will be incorporated into 'The Essex County Council (Tendring District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019' by substituting map tile: TM185 177 Revision 0 to Revision 1.
