The Essex County Council (Various Roads, Thaxted) (Restricted Roads and 40mph Speed Limit) Order 202*

The Essex County Council (hereinafter referred to as "The Council") in exercise of its powers under Sections 81, 82(2) and 83(2), 84(1)(a) and (2), and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order: -

- 1. The lengths of road as specified in Schedule 1 to this Order shall become restricted roads for the purposes of Section 81 of the Act.
- 2. No person shall cause or permit any vehicle to be driven at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 2 to this Order.
- 3. The restriction imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
- 4. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 5. 'The Essex County Council (Various Roads, Thaxted) (Restricted Road and 40mph Speed Limit) Order 2020 is hereby revoked in its entirety. The restrictions contained within that Order shall continue in force by virtue of this new Order.

Schedule 1 – Restricted Road

Road	Description
Bardfield Road	From its junction with the B184 Dunmow Road eastwards to a point approximately 911 metres east of the junction with Magdalen Green, a total distance of approximately 1,021 metres.
Bolford Street	From its junction with the B184 Watling Street, southwest for approximately 253 metres.
B184 Dunmow Road	From the terminal point approximately 136 metres south of its junction with Bardfield Road (adjacent to the property known as Court Cottage), southwards to a point approximately 50 metres south of the southern boundary of the property known as Totmans Farm, approximately 175 metres.
B1051 Park Street	From its junction with Town Street (B184) south-westwards to a point approximately 261 metres southwest of its junction with Star Mead, a total distance of approximately 322 metres.

Schedule 2 – 40mph Speed Limit

Road	Description
Bardfield Road	From a point approximately 20 metres west of its junction with Little Sampford Road (Bardfield End Green) in a generally easterly direction for approximately 1025 metres.
Bolford Street	From a point approximately 253 metres southwest of its junction with the B184 Watling Street, in a south westerly direction for approximately 210 metres.
Little Sampford Road (Bardfield End Green)	From its junction with Bardfield Road in a generally north- easterly direction, for approximately 1110 metres.
Thaxted Road/Bolford Street	From a point approximately 420 metres southeast of Cutlers Green Lane to a point approximately 570 metres northwest of that junction, a total distance of approximately 990 metres.
Bardfield Road (side road previously referred to as Elder Street)	From its junction with Bardfield Road, to its junction with Little Sampford Road (Bardfield End Green), a northeasterly then northerly direction for approximately 361 metres.
