The Essex County Council (Various Roads, Thaxted) (Restricted Road and 40mph Speed Limit) Order 2020

The Essex County Council ("the Council") in exercise of its powers under Sections 81, 82(2) and 83(2) and 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulations Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:-

- 1. The lengths of road specified in Schedule 1 to this Order shall become restricted roads for the purpose of Section 81 of the Act.
- 2. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour in the lengths of road specified in Schedule 2 to this Order.
- 3. 'The Essex County Council (Various Roads, Thaxted) (Restricted Road & 40MPH Speed Limit) Order 2014' is hereby revoked. The restrictions contained within that order shall continue in force by virtue of this new order.
- 4. This Order may be cited as The Essex County Council (Various Roads, Thaxted) (Restricted Road and 40mph Speed Limit) Order 2020 and shall come into operation on 7 August 2020.
