The Essex County Council (Harlow District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.59) Order 202*

Notice is hereby given that the Essex County Council proposes to make the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

Effect of the Order: To implement: 'No Waiting at Any Time' restrictions.

Sunny Court/Croft junction with Little Pynchons	BOTH SIDES From its junction with Little Pynchons, north/northwest for approximately 10 metres.
Little Pynchons junction with Sunny Court/Croft	NORTH SIDE (i) From its junction with Sunny Court/Croft, northeast for approximately 10 metres. (ii) From its junction with Sunny Court/Croft, southwest for approximately 10 metres.
Wharley Hook (West) junction with Little Pynchons	BOTH SIDES From its junction with Little Pynchons, south for approximately 10 metres.
Little Pynchons junction with Wharley Hook (West)	SOUTH SIDE (i) From its junction with Wharley Hook (West), southwest for approximately 10 metres. (ii) From its junction with Wharley Hook (West), northeast for approximately 10 metres.
Little Pynchons (West) junction with Little Pynchons	BOTH SIDES From its junction with Little Pynchons, northwest for approximately 10 metres.
Little Pynchons junction with Little Pynchons (West)	NORTH SIDE (i) From its junction with Little Pynchons (West), southwest for approximately 10 metres. (ii) From its junction with Little Pynchons (West), northeast for approximately 10 metres.
Wharley Hook (East) junction with Little Pynchons	BOTH SIDES From its junction with Little Pynchons, southeast for approximately 10 metres.
Little Pynchons junction with Wharley Hook (East)	SOUTH SIDE (i) From its junction with Wharley Hook (East), southwest for approximately 10 metres. (ii) From its junction with Wharley Hook (East), northeast for approximately 10 metres.
Little Pynchons (East) junction with Little Pynchons	BOTH SIDES From its junction with Little Pynchons, northwest for approximately 10 metres.
Little Pynchons, junction with Little Pynchons (East)	NORTH SIDE (i) From its junction with Little Pynchons, southwest for approximately 10 metres. (ii) From its junction with Little Pynchons, northeast for approximately 10 metres.
