The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No.58) Order 202*

The Essex County Council (Wharf Road, and Bow Bridge Road, Chelmsford) (7.5 Tonne Environmental Weight Restriction) Order 202*

The Essex County Council (Wharf Road, and Bow Bridge Road, Chelmsford) (20mph Zone) Order 202*
Raised Tables, and Buildout – Wharf Road

Notice is hereby given that the Essex County Council proposes to make the above Orders under sections 1(1), 2(1) to (3), 3(2), 4(1), 4(2), 32(1), 35(1), 45, 46, 47, 49, 53, 84(1)(a) and (2), and Parts IV and III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended), and Section 90(A-F) of the Highways Act 1980.

Effect of the order

- 1. To Revoke:** 'No Waiting 8am-6pm' Restriction and **Implement:** 'No Waiting at Any Time' Restrictions.

Road	Description
Wharf Road	West Side From its junction with Navigation Road, southwest for approximately 133 metres. East Side From its junction with Navigation Road, southwest for approximately 93 metres. Northeast Side From a point in line with the south-eastern kerb line of Bow Bridge Road northwest for approximately 81 metres. Southwest Side From a point in line with the north-western kerb line of Bow Bridge Road, northwest for approximately 61 metres.

- 2. To Revoke:** 'No Waiting at Any Time' Restrictions

Road	Description
Bow Bridge Road (formerly known as Baddow Road)	Both Sides: From its junction with Baddow Road northeast for approximately 30 metres.
Baddow Road	East Side: From its junction with Bow Bridge Road northwest for approximately 8 metres.

- 3. To Implement:** 'No Waiting at Any Time' Restrictions

Road	Description
Bow Bridge Road	Both Sides From its junction with Wharf Road, southwest for approximately 6 metres.

- 4. To Implement:** a 'No Stopping at Any Time – Red Route' Restriction.

Road	Description
Bow Bridge Road	Both Sides: From its junction with Baddow Road, northeast to a point approximately 6 metres southwest of its junction with Wharf Road, including both sides of the entrances to Bow Bridge Road Car Parking East, and West.
Baddow Road	North Side From its junction with Bow Bridge Road northwest for approximately 8 metres.

This Order will be incorporated into 'The Essex County Council (Chelmsford City) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019' by substituting Map Tiles: TL710 062 Revision 2 to Revision 3, TL710 065 Revision 1 to Revision 2, TL710 067 Revision 2 to Revision 3.

Notice is hereby given that the Essex County Council proposes to make the above Order under sections 1(1), 2(1) to (3), and 3(2), and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended).

5. To Implement: a '7.5Tonne Environmental Weight Limit' Restriction.

Road	Description
Bow Bridge Road	From its junction with Wharf Road, southwest to a point approximately 30 metres northeast of its junction with Baddow Road.

6. To Implement: a '7.5Tonne Environmental Weight Limit Except for Access' Restriction.

Road	Description
Wharf Road	From its junction with Navigation Road for its entire length.
Bow Bridge Road	From its junction with Baddow Road, northeast for approximately 30 metres.

Notice is hereby given that the Essex County Council proposes to make the above Order under section 84(1)(a) and (2), and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

7. To Implement: a "20mph Zone"

Road	Description
Wharf Road	From its junction with Navigation Road, southeast for approximately 402 metres (to where the 30mph Speed Limit will begin).
Bow Bridge Road	From its junction with Wharf Road, south-westwards to a point approximately 30 metres northeast of its junction with Baddow Road (to where the 30mph Speed Limit will begin).

Notice is hereby given that the Essex County Council proposes to implement Raised Tables under Section 90(A-F) of the Highways Act 1980.

8. To Implement: 'Raised Tables'.

Road	Description
Wharf Road	<ul style="list-style-type: none"> (i) From a point approximately 12 metres southwest of its junction with Navigation Road, southwest for approximately 16 metres. (ii) From a point approximately 74 metres southwest of its junction with Navigation Road, southwest for approximately 16 metres. (iii) From a point approximately 350 metres southeast of its junction with Navigation Road, southeast for approximately 25 metres. <p>The height of the Speed Tables is 125 mm with a gradient of 1:15 Ramp.</p>

Notice is hereby given that the Essex County Council under the Highways (Traffic Calming) Regulations 1999 proposes to implement the following.

9. To Implement: a 'Build out'

Road	Description
Wharf Road	North Side: From a point approximately 109 metres northwest of the north-western kerb line of Bow Bridge Road northwest for approximately 13 metres.

10. To Implement: a 'Road Narrowing'.

Road	Description
Wharf Road	Both Sides: From a point approximately 191 metres northwest of the north-western kerb line of Bow Bridge Road northwest for approximately 2.5 metres.
