## The Essex County Council (Various Roads, Great Bentley) (Combined Speed Limits) Order 202\*

**Notice is hereby given** that the Essex County Council proposes to make the above Order under sections 84(1)(a) and (2), and Parts IV and Part III of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended)

## Effect of the order:

1. To Extend: an existing '30mph Speed Limit' (Currently a 40mph Speed Limit)

Ī	Plough Road, Great	From a point approximately 245 metres south of its junction
	Bentley	with Hall View Road, south for approximately 31 metres.

'The Essex County Council (Tendring District) (40mph Speed Limit) (No. 2) Order 2010' is hereby revoked insofar as it relates to the lengths of road, in the Parish of Great Bentley. All other roads not mentioned above shall continue in force by virtue of the existing Order. 'The Essex County Council (Plough Road, Great Bentley) (40mph Speed Limit) Order 2014' is hereby revoked in its entirety. All restrictions shall continue in force by virtue of the new Order.

'The Essex County Council (Various Roads, Great Bentley) (20mph Zone, Restricted Roads and 30mph Speed Limit) Order 2024' is hereby revoked in its entirety. All restrictions shall remain in force by virtue of the new Order.

Cinderpath Way, Great Bentley (Private Road) will be a '30mph Speed Limit Restricted Road by virtue of Street Lighting' as shown on the plan in salmon from its junction with Plough Road east for approximately 15 metres.

2. To Implement: a 'No Stopping at Any Time Except for Buses' Restriction

Plough Road, Great Bentley	<ul> <li>West Side: From a point approximately 45 metres south of the northern extended kerb line of Cinderpath Way, south for approximately 12 metres.</li> <li>East Side: From a point approximately 60 metres north of the northern extended kerb line of Cinderpath Way, north for approximately 12 metres.</li> </ul>
