Brewster Court	WESTERN AND NORTHEN SIDE: From its junction with Lancaster Avenue, north and east (including the turning head to the east), to a point approximately 34 metres north of its junction with Lancaster Avenue. EASTERN SIDE: From its junction with Lancaster Avenue, North for approximately 13.5 metres.
Sunderland Avenue	 EASTERN SIDE: From its junction with Lancaster Avenue, South for approximately 15 metres. WESTERN SIDE: From its junction with Lancaster Avenue, south for approximately 61.5 metres. From a point approximately 76.5 metres south of its junction with Lancaster Avenue, south for approximately 3.5 metres. From a point approximately 99 metres south of its junction with Lancaster Avenue, south for approximately 17 metres. From a point approximately 20 metres south of its junction with Mosquito Way. From a point approximately 40 metres south of its junction with Mosquito Way, south for approximately 45 metres.
